Waste/Water Operator, Tom Valerius was present. 1.4 million gallons of water, 3 high meter reads when doing bills this month. Samples taken on waste water. Was wondering if the baseball team was done watering. Would like to get the water shut off for the year. Need to get ad run in the paper for Tom's Position.

New Munich Jaycees—Bill from City Wide Garage Sales. Jaycees will be done at the end of the year. Lions will start gambling hopefully November 1.

Building Permits—Monica Rieland-Replace shed door with larger one on the North side. New Munich Area Veterans-Veterans memorial in the city part. 30x30 concrete slab with granite monuments. Rick Rolfzen-Replace siding on house and deck on east side of house. Was charged a fine for doing the work with no permit. Peyton Linn-Patio 14x24 on west side of house. Replace shingles.
