Sunday Evening in the Colonies

Iowa County Sheriff Rob Rotter confirmed that a female suspect is believed to have entered a garage on K Street in Middle Amana and removed two weed eaters the evening of Sunday, Jan. 28th.

The same suspect was spotted in the village of Amana at Good Quilts, Great Gardens at 708 47th Ave. Sunday evening attempting to take items from the business and piling them up, perhaps to make them easier to load. The suspect was stopped by the owner of the business. The female suspect then fled in an older model white SUV/ mini van. No items were taken. Her image was caught on camera by the owner of the Amana shop.

Sheriff Rotter said that they have a "good lead" on the identity of the suspect and will be following up the investigation.

Amana Freezer Run Winner from OK State

Jared Haltom, of Broken Arrow Oklahoma, beat out over 300 competitors including multi-time champ Nathan Hopp to win the Amana Freezer 5k.

The 41-year-old's winning time was 15:44. Second was John Donovan, 24 of Iowa City with 15:50 followed by Tyler Sullivan, 29 of Iowa City at 16:29 and Nathan Hopp, 35, Amana at 16:58.

A total of 317 people were officially entered in the race though others may have paid the entry fee and crossed the finish line after the official times were recorded. Close to 400 people participated in the fun run that's become a winter fixture on the eastern lowa running scene. It's a benefit for the maintenance of the Amana Kolonieweg Recreational Trail.

The overall female winner was Alice Anderson, 35, Marion with a time of 19:14.

Luke Karsten, 7, of Amana was among the very youngest to compete winning 7th place in the male 14 and under division. Emma Karsten, 9, Amana was 7th in the female 14 and under division with Hayden Ehrle, 14 placing 8th in that group.

The race took place at 10 a.m. on what many think was one of the warmest Winterfest's ever. It was 34 degrees and sunny with only a light breeze. Many racers competed in traditional running gear (shorts and t's) or light jackets.

Alas, something interesting in the classified ads. A like-new Roland V Drum set TD-4KP with Peavy KB2 amplifier and extras. This is a very compact, portable drum kit that folds quickly and easily for storage or transport. The kit has never been played outside of my home and is in near-perfect condition. The kit consists of 7 1/2 inch cushioned rubber toms and snare, two 10 inch cymbals and a 10 inch high hat, kick drum trigger, Roland FD8 high hat pedal and Roland D4 controller. All drums and triggers are in mint condition. Included is a new Drum Workshop DW 2000 kick pedal. The Roland D4 controller features a wide range of programmable drum and percussion sounds. There are 125 sounds and 25 different drum kits available, the drums can be tuned or muffled to suit. All sounds can be modified to create a wide variety of tones and effects. There is a record capability, a coaching mode with exercises, a headphone connection and a 'mix in' connection to allow playing with an external audio source. The original Roland AC adaptor is included. An optional mesh snare could be purchased from Roland. Also included is a mint Peavy KB2 keyboard amplifier that I use with this kit. This is a 4 channel 45 watt amplifier with a 10 inch coaxial speaker. Channels 1 and 2 have 1/4 inch inputs, channel 3 has XLR and 1/4 inch inputs and channel 4 features a ¼ monitor input with level control. There are FX sends and returns and a headphone jack. Two good Fender instrument cables to connect the amp to the kit are included as well as headphones with extension cable, new drum sticks and a cheapo drum throne. I have all of the original manuals and instructional CD. A Gator G-Roto 212 rolling case for storage / transport is included. This was originally intended as a 2 x 10 guitar amplifier case but works well for the Roland kit. All you need is electricity to have a great small kit. Quiet enough for practice, good enough for gigging and compact enough for younger drummers. Roland is the good stuff. \$700.00. Call 622.6242 any time before midnight.
