- 10. By Laws Committee
 - a. Need a minimum of 3
 - i. Update and discuss changes that are needed to the existing bylaws
 - Section 4, Article A, 2
 - The treasurer shall invoice each member for appropriate dues after January 1st of each calendar year (this needs to be changed to September 1) Dues shall be considered delinquent after March 31st of the same calendar year. (This needs to be changed to December 31st)
 - Members who have been dropped may reapply for membership the following year. (Yet we accept membership ALL year round, should we even keep this?)
 - Section 6: Resignations
 - This states at the bottom: Individuals may resign their membership in the association by electronic notice to any Executive Board member. (We should also add something here in this section that if a member is deemed unfit/non-trust worthy, the executive board may revoke their membership status)
