AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS PROVIDING THAT E. 15<sup>TH</sup> STREET BETWEEN HUMBLE AVENUE AND WALNUT STREET BE CLOSED AND THAT THE DEDICATION OF THE RIGHT-OF-WAY BE VACATED AND ABANDONED, EXCEPT FOR THE EXISTING UTILITY AND/OR DRAINAGE EASEMENTS; PROVIDING FOR REVERSION OF THE FEE IN SAID LAND; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON FINAL PASSAGE. ### E. Consider and Discuss Ordinance No. 0-2020-07

AN ORDINANCE OF THE CITY OF CISCO, TEXAS AMENDING CERTAIN SUBSECTIONS OF CHAPTER 5 "ANIMALS AND FOWL" OF THE CITY'S CODE OF ORDINANCES; SPECIFICALLY SECTION 5-20 "DISPOSTION OF UNCLAIMED DOGS", TO INCLUDE THE AUTHORITY TO REHOUSE UNCLAIMED DOGS AND ESTABLISHING AN ADMINISTRATIVE REHOUSING FEE. (First Reading)

Mr. Archer explained that the proposed ordinance would give the Animal Control Officer the authority to rehouse abandoned or surrendered dogs and establishes a fee for the service. Council discussed the particulars of rehousing a dog and if the Animal Control Officer requires vaccinations or for the animal to be spayed or neutered. There was discussion of the city performing these services and then passing those fees on to the adopter, but eventually, the Council agreed that that measure might prohibit people from adopting a dog from the facility. The Council requested that the Animal Control Officer attend the next meeting to answer specific questions about the rehousing process and provide statistics regarding repeat offenders.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS PROVIDING THAT AVENUE G FROM THE SOUTH LINE OF W. 20<sup>TH</sup> STREET TO THE NORTH LINE OF W. 21<sup>ST</sup> STREET AND THE ALLEY WAY BETWEEN W. 20<sup>TH</sup> STREET AND W. 21<sup>ST</sup> STREET BE CLOSED AND THAT THE DEDICATION OF THE RIGHT-OF-WAY BE VACATED AND ABANDONED, EXCEPT FOR EXISTING UTILITY AND/OR DRAINAGE EASEMENTS; PROVIDING FOR REVERSION OF THE FEE IN SAID LAND; AND, PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON FINAL PASSAGE. (First Reading)

Mr. Archer commented that the property is currently owned by the Economic Development Corporation and they have a prospective buyer who would like to develop the property if the city is willing to abandon the undeveloped right of way.
