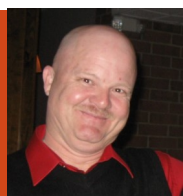

Lessons as always are free but we have to give up one of our nights to do this so they will be expected to dedicate their nights for the five week course.

Officer Responsibilities

Every year at this time it is the privilege of our club members to elect new officers to serve us in the coming year. There has been much confusion over the responsibilities of officers and who can actually serve in which offices. To be nominated for President or Vice-President, a member must be in good standing for two years and must have served for at least one term as a member of the Board i.e. an officer or a committee chairman. All other offices shall be from the membership.

President:

Scheduling and conducting all of the meetings., Preparation of meeting agendas. Appointing (with input from executive board) all committee chairmen., Appointing all special committee members, as needed., To review all club expenditures., To promote the club to other clubs and organizations. To stand and speak for the club as directed by the general membership.

Vice President:

To assume the duties of the president in the president's absence., Other duties as directed by the president or the general membership., Shall act as club parliamentarian and be responsible for proper election procedures and vote counting.

Secretary:

To record, maintain and distribute the minutes at all meetings., Report minutes at the monthly business meetings., To maintain historical rule of membership lists, meeting minutes and treasurer's report., Receiving and distribution of club mail., To call a meeting to order in the absence of the president and vice-president until a chairperson pro-tem can be nominated.

Treasurer:

To receive and bank all monies due to the club., To be responsible for the manning of the door at all club functions where monies are received and maintain attendance records., To distribute club funds, as directed by the club or the bylaws., To maintain written records of the financial transactions., To make written copies of the club's financial condition available at the monthly business meetings., Maintain a historical record of all matters to do with finances of the club.

Sgt. at Arms:

To maintain order at all club functions., Will accept, in writing, any and all grievances., All grievances will be handled on a monthly basis and either acted upon by the Sgt. at Arms, or passed on to the executive board for action. If executive board cannot handle or satisfy the grievance, it will be presented to the general membership for resolution at the next business meeting., All grievances will be held in strict confidence. Forfeiture of club membership is the penalty for breaking such confidence. If a grievance is required to be presented to the executive board or to the general membership, it will be presented anonymously by the Sgt. at Arms.

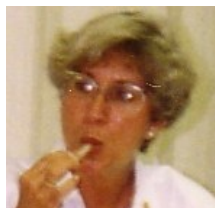
Nominations will be accepted from the floor at the October dance. Make sure you have contacted the ones you want to nominate and they are willing to serve before submitting their names.
