There being a quorum, Mayor Pro-Tem Pitts called the meeting of the Vienna City Council to order at 6:30 p.m.

### **NEW BUSINESS**

Alderman Racey made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the December 6, 2023 meeting minutes, the Warrant (\$18,164.18), and November Treasurer's Report. Alderman Hill seconded the motion. All present in favor, motion carried.

County Commissioner, Jason Taylor was present to request closure of one block of  $6^{th}$  Street concerning new county courthouse parking plans. Taylor said the county would grant the city access to the parking lot for any utility repairs. Council said they would consider the request.

Scott Hickam, Buessink & Hickam, PC presented the 2023 fiscal year financial report with city officials.

Alderman Tuey made a motion to Approve and Accept the 2023 fiscal year annual financial report. Alderman Hill seconded the motion. All in favor, motion carried.

Alderman Moore made a motion to Authorize and Approve Ordinance 23-04, An Ordinance Amending and Establishing Natural Gas Rates. Alderman Hill seconded the motion. All in favor motion carried.

Alderman Hill made a motion to Authorize and Approve an amendment to Natural Gas Management agreement between Utility Gas Management and City of Vienna, IL. Alderman Racey seconded the motion. All in favor, motion carried.
