BURNING ON YOUR OWN PROPERTY

If you plan to do yard waste burning on your property you **must** get a burn permit beforehand from Benton County. (If you don't and a fire truck comes out because someone reports smoke at your property, you will be charged for the fire service call.) Call **Benton County at 1-866-207-5140.** Burn Ban info can be found on our website: www.lbvca.com.

(Burning of construction materials is prohibited.)

Do not leave smoldering fires unattended!

CLEANING UP YOUR PROPERTY:

Please remember: Be a good neighbor and rake out leaves and tree debris from your ditches and culverts to prevent water run-off problems, and either burn them or haul them away. If you hire someone to rake leaves or clear other yard waste from your property be sure to tell them to NOT push it into a ditch or culvert or into the street. You must take it to Inland Waste Service (479-878-1384) for disposal. You will be charged a clean-up fee if LBVCA has to clean out your ditch.

INJURED OR DEAD ANIMALS: To report an injured or dead animal (deer, raccoon, etc.) and have it removed from a <u>state</u> culvert or <u>state</u> road, contact the **Arkansas Game & Fish Department** at 1-866-253-2506. (They'll need the street address of where the animal is located.) If you find a dead animal or **deer parts** on your property (left behind by illegal hunters), you may bury them but <u>NOT</u> burn them (according to the AR Dept. of Environmental Quality).

We've recently learned both the Benton County Roads Dept. and Sheriff's Dept. say they have no program in place for picking up dead deer from county roads or culverts. If the animal is lying in a culvert, notify the AR Dept of Environmental Quality at 1-888-233-0326.

SPEED LIMIT & PARKING in LBV: The speed limit throughout the Village is only **20mph** and is enforceable by the Benton County Sheriff's dept. There is <u>no</u> on-street parking throughout LBV.

VILLAGE ROADS:

Green and Blue street signs in the village are county roads. If you live on a road with potholes or lots of ruts, call Jeff Clark at the Benton County Roads (479-271-1052) to have it repaired. You do not need to call the Village Office or wait for a Board meeting to report it.

AIRSTRIP NEWS

The annual Fly In on September 12th was a success. Although attendance was down somewhat from last year due to competing activities, a good time was had by all. The weather couldn't have been better. Many thanks to the Second Wind Band and the volunteers in the stylish new "LBVCA Event Staff" vests who kept the food moving and the runway environment safe.

I wasn't sure it could be done, but the pilots of LBV and a few non-pilot volunteers completed the crack filling of the runway in time for the fly-in. The crack filling should help defer the need for an overlay as well as reduce the cost of maintenance. With smaller annual touch-up filling operations, the runway service life of the pavement should be longer than if cracks are allowed to grow and become homes for weeds and grass. Based on the amount of crack filler used and the manufacturer's recommended contractor rate of \$1.00 per linear foot, the Village received approximately \$6000 in value from the volunteer work this year in addition to owning the equipment. The donations of money and effort by these folks have really made a difference.

"renting" the facility will be responsible for cleaning up and any damages. For complete rules, contact Marty in the office.



As of January 2014, the LBVCA ACC works with the Benton County Inspectors as part of the permit issuing process and Covenants building requirements. Benton County performs the building inspections, and failure to obtain a permit can be quite costly in fines if you get caught building without one.

ACC Building Standards & Practices are available on the LBVCA website (<u>WWW.LBVCA.COM</u>). Please take the time to read them carefully.

The Architectural Control Committee, an important subset of the LBVCA Board, invites applicants to join. Roads & Maintenance — The Road Ahead By Jon Testut

As always, our Roads & Maintenance man is hard at work making the Village a more beautiful place to live. Roadside mowing, parks grass cutting, street tree trimming...all hard but satisfying work. Be careful as you drive on Village roads, noting that the equipment operator may not see or hear you while he is operating the equipment. Give him a width berth.

As you know, the Burn Pile has been closed for the time being. Please do not bring your yard waste to the site since the gate has been locked and code access deactivated. DO NOT leave these items at your curbside as the village CANNOT pick them up. If you choose to burn these items on your own property, please check if there is a Burn Ban on for the day. Be sure to call CENCOM (1-866-207-5140) to notify them of your intention to burn. Failure to do both of these may lead to an illegal burn and subsequent fines. Be safe, not sorry.

One last item...when attending to your yard maintenance, please do not direct or discharge grass clippings, leaves, branches and the like into the streets and roadways, or ditches and culverts. This not only becomes a hazard, but detracts from the overall effort to beautify the Village.
