PRESIDENT'S MESSAGE

December 2017

Last year, December of 2016, we were celebrating the community's recovery from hurricane Hermine that caused so much damage on the Beach in September of 2016. This December we are thankful to have been spared the devastation that had been predicted to happen from hurricane Irma, September of 2017. All home owners on the coast breathed a sigh of relief when it turned before reaching Tampa Bay, that was a very frightening week.

Our elected HBPOA board for 2018 will be Kathy Frase as President, Bennie Martinez as Vice President, Pat Cordova as Secretary, Margo McConnell as Treasurer, Gladys Moore as Past President, and Diane Greenwell and Laine Wightman as directors with Joy Martinez and Vicki Anderson to finish the last year of their second term as Directors. Let us all give our new board our full support this coming year as they work toward the betterment of our beautiful community. HBPOA strives, through its officers and directors, and our Government Affairs Committee (GAC), to be the voice of the residents of Hernando Beach to Hernando County Government, SWFWMD, and Florida state in matters that directly affect Hernando Beach.

The Landscaping Committee reported that the leaks in the pond at our Dolphin Fountain at US Highway 19 have been an ongoing source of cost to HBPOA. The county has made repairs and has the fountain up and running again but there still seems to be a leak somewhere within the system. County officials plan to shut it down once again to try to find and fix the leak once and for all. The Triangle Park has been getting a much-needed facelift from the overgrown bushes being trimmed back. We have had damage there twice this year from vehicles going too fast to make the turn from Shoal Line onto Osowaw Blvd. One vehicle took out part of the irrigation system, AJ's Pump and Sprinkler repaired that, then there was a second accident. That accident damaged a hose bib and two memorial benches. John Romanyak from Coastal Pro repaired the hose bib for the community and Don Bowers and George Watkins repaired and reinstalled the 2 benches. Harry Bulow repaired some of the electrical system and a spot light, plus Tim Goodman and Don





MINUTES OF HBPOA MEETING COAST GUARD BUILDING NOVEMBER 2, 2017

Gladys Moore, President, called the monthly meeting of the HBPOA to order at 7:05 PM and then lead those present in the Pledge of Allegiance. She explained that Kathy Frase could not attend our meeting tonight because she is recovering from surgery for a broken hip.

Betty McGuire moved that the minutes of the October meeting be accepted as published in the November Beachcomber. Cal Holland seconded the motion which carried unanimously.

In Margo McConnell's absence, Gladys Moore gave the treasurer's report as follows: Balance on hand as of October 31, 2017, in our General Account was \$12,979.31. For our Entranceway Account the balance on hand as of October 31, 2017 was \$3256.03. The report will be filed for audit. (For accuracy it must be noted that Gladys wasn't able to pull up on her cell phone the report that had been emailed by Margo;

however, she assured everyone that we are in good shape financially and encouraged anyone interested to call or email her for the details.)

Reports: Publicity/Beachcomber...Jen Brown reminded the members that the cutoff date for the December issue will be (as always) the tenth of the month. She also announced that the photo contest winner for this year was Maggie Shealy and pointed out the winning photo on the cover of our current issue.

Landscaping...Gladys Moore explained that once again our Triangle Park had sustained damage from a careless driver (who apparently fled the scene) and thanked those who had assisted in making the needed repairs: John Romanyak from Coastal Pro, Don Bowers, and Kathy and George Watkins. Thanks to their efforts, no payment from insurance was needed. She also thanked Ken and Margo McConnell and Cal Holland for helping her in the task of the cleanup of bushes which had become quite overgrown and in weeding. The plan is to plant Encore Azaleas, the number to be based upon contributions from members

(\$12 for small and \$17 for larger, checks to be made out to HBPOA).

Hospitality...Fran Baird reported for Kathy Frase that our Christmas party will be on 12/02/17 at 6 PM here at the Coast Guard building. The association will provide ham and chicken while the members who are coming are being asked to bring a covered dish to share. Please let Kathy Frase know ASAP how many will be coming from your house and what dish you plan to bring. The party is not limited to members but to any HB resident or guest. No alcohol can be consumed or brought on the premises. There will be an Angel Tree up for the party for the Angel Cards which Fran has tonight for any interested parties. Minimum donation is \$2 although more is encouraged with proceeds going to the Boys' and Girls' Clubs. The cards will be available also at the party for purchase.

GAC...Chuck Greenwell informed us that our BOCC are working on several issues that are very important to homeowners in Hernando Beach :

1) The 5 year, 50% Repetitive Loss Assessment that the county makes on homes that have been damaged due to floods. Once the cumulative damage reaches 50% of the appraised value of a home, the county will step in and require the homeowner to bring the house up to the current code which, for a single level house, means putting the house up on stilts or tearing the current house down and building a stilt home. Steve and Pat Barton have been working on this issue, as well as Gladys Moore who is very knowledgeable about it. The entire community is urged to unite behind these individuals since the repercussions could be dire.

2) Nonconversion Agreement. Some homeowners may have already been required to sign one of these agreements which basically requires anyone wishing to make improvements on his/her home to go through all manner of red tape to ascertain if any of them might be in violation of their current code. In a nutshell this is all about keeping stilt homes just that and not filling in that area. It also involves new construction. Apparently this has been in effect since January 18, 2014 and

has been going on since. If a nonconversion agreement has been signed by a previous owner of your home, that agreement transfers automatically if the home is sold. Here again, contact people are Steve and Pat Barton and Gladys Moore who offered to anyone interested a copy of the agreement. Both of the above could affect anyone of us at some point in time and Chuck emphasized how imperative it is for the community members not to remain apathetic but to become informed and involved.

3) The Legislative Delegation spoke recently in Hernando County and we were on the list of topics for discussion regarding needed improvements on Calienta's water drainage problem, sidewalks and approval for design of new construction in that area. It was Chuck's impression that the legislators were actually reaching out and enquiring as to whether we wanted funding for construction and not just design. He believes that we are going to get some action at the state and county level on this.

4) Chuck has come to the conclusion after being

involved for several years as chairman for the GAC, that Hernando Beach residents rarely appear at a BOCC meeting which is the only place to be informed about issues important to us. He strongly encouraged residents, particularly members of the HBPOA to attend these meetings when we can. He also emphasized the importance of attending the Port Authority meetings. Unfortunately the objectives of the county commissioners, as expressed in the proposed agendas, are not always clear. We must insist upon more transparency and better stated agendas by our representatives.

5) Brownfield Act. The last of three hearings will be 12/5/2017.

6) Finally Chuck reminded us that he is looking for someone to take over the chairmanship of the GAC, someone who is willing to devote the time and have the qualifications and experience to chair this very important committee. He promised that he will not be quitting until the position can be filled. It is a very demanding job but so important to our community.

HERNANDO COUNTY'S ARTIFICIAL REEFS AND PLANS FOR THE FUTURE

Hernando County has had a long history of artificial reef construction thanks to the support of its residents, fishing clubs, dive shops, members of the Hernando County Port Authority and the Board of County Commissioners and especially the support and involvement of County Commissioner Wayne Dukes. Through this grass-roots initiative and continued community support there has been a concerted effort to create viable and diverse marine habitats, while also creating interesting underwater destinations for scuba divers and free-divers. Today there are a total of 4 artificial reefs that range from 15 nm to 20 nm offshore in water depths ranging from 18 to 25 ft depth. Collectively, the County's artificial reefs benefit both the local economy and enhance our quality of life through increasing opportunities for fishing, diving, and spear-fishing.

The County's artificial reef projects actually started in the late 1970's with the deployment of Richardson reef, followed by its expansion in 1987, and the creation of the Jim Champion Reef in 1991. These reefs





were constructed of concrete culverts and various types of concrete rubble and even a sunken barge. In 1994 and 1995 two different types of reefs were deployed with one reef constructed of 180 reef ball modules (1994), and was simply named the Reef Ball reef. In 1995 Hernando County was fortunate to be part of multi-county cooperative project with the US Army, named Operation REEFX. The purpose of operation REEFX was to deploy surplus US Army Sherman M-60 tanks to create unique fishing reefs that not only serve as tributes or memorials to our Veterans but also create exciting dive sites. The tanks provide both high relief structure and deep cover habitat for desirable fish like both gag and red grouper, mangrove and gray snapper, Spanish mackerel, but also pelagic species including amberjack, cobia, and kingfish. Although the tanks can be snorkeled during the spring and early summer when the water is typically the clearest, scuba diving is the best way to explore the tanks up close. The army tank reef in Hernando County known as "Bendickson" reef was named after a long term member of the Port Authority similar to both Richardson reef and Jim Champion reef (Figure 1). Additional deployments of material have taken place through time at these three reef with the most recent deployment taking place in 1997. It's important to note that the earlier reef projects were made possible through grants obtained from the Florida Department of Environmental Protection and more recently from grants obtained from the Florida Fish and Wildlife Conservation Commission.

pleted in August with 600 tons of a variety of pre-cast concrete structures deployed. The project was funded by a grant through the Florida Fish and Wildlife Conservation Commission Artificial Reef Program. The material was deployed on sand bottom areas near the army tanks to create additional structure for fish habitat. A wide variety of structures were deployed at three locations. These included three massive 38,000 lb box culverts, four 60 inch culverts, twelve 48 inch culverts, and approximately 300 concrete pipes ranging in size from 15 inches to 36 inches (Figure 2). Other structures deployed included 30 miscellaneous junction boxes and manhole basins, as well as, custom fabricated pyramid modules (Figure 3) constructed by Colleen Marine, the reef contractor selected for this project. All of the materials deployed were provided by the contractor and shipped from the contractor's facility in Port St Joe in the Panhandle with the barge captain transporting the material over 225 miles to reach the Bendickson Reef site.

With the completion of the expansion of the off-shore reef expansion, the next project to be completed are three shallow water reefs located within

close proximity to shore at locations 6 to 7 miles west and northwest of Hernando Beach. This project will provide greater accessibility of artificial reefs and recreational fishing to Hernando County's residents and are anticipated to provide almost immediate recreational benefits since they will be accessible to family's owning smaller vessels. Each reef will be comprised of an array of reef ball modules weighing 1400 lbs each, providing the complex structure needed to create habitat for a diverse population of fish, while also providing interesting structure for snorkelers. The shallow depths of the reefs will make these sites ideal for snorkeling to view many species of fish and marine life, and will become a popular destinations for both residents and tourists that wish to explore the underwater marine environment. The anticipated deployment date for the three shallow will be this fall and is expected to take two to three weeks with good weather conditions.

Once the shallow reefs are deployed there will opportunities additional community involvement through volunteer clean-ups of the reefs and for individuals or businesses that would like to sponsor their own reef ball for future reef deployments. The






