

OFFICIAL RULES – RAFFLE MY HEART (AN AFFAIR OF THE HEART) FUNDRAISER:

PRIZES: There will be Five (5) Prizewinners selected with prizes as follows:

1. **GRAND PRIZE:** 2017 PORSCHE BOXSTER. All details of the Grand Prize vehicle to be determined by Helping Healing Hearts (“Sponsor”) in its sole discretion. Manufacturer’s Estimated Retail Price: \$ 73,715. Any depiction of prize is for illustrative purposes only. Grand Prize vehicle will only be delivered within the 48 contiguous United States and the District of Columbia (excluding Alaska, Hawaii, Puerto Rico, Guam and US Virgin Island). All payments are in US funds. Ticket sales are final, no refunds or exchanges. No portion of the Raffle ticket price will qualify as a charitable contribution for federal income tax purposes. All net proceeds go directly to support Helping

Healing Hearts Inc. It is a violation of federal law to send Raffle tickets or any information related to the Raffle via the federal mail system, and such violations may lead to criminal penalties. Prizewinner is responsible for all costs associated with delivery of the vehicle to its destination. PRIZE DRAWING: Prizewinners will be randomly selected and announced from all eligible entries received during the promotion period out of all tickets sold based on a random drawing scheduled to be conducted on or about February 22, 2017. Prizewinners will be notified on or about March 1, 2017 via phone and/or email, and the Prizewinner's name may be posted on Sponsor's website and included in press articles on or about the same date. The Prizewinner may be required to sign and return, where legal, an Affidavit of Eligibility and Liability/Publicity Release within five (5) days of prize notification.
