


For the lady barrister, it's the <u>Olmstead V. L. C.</u> law suit, a fashionable but conservative choice that will show the feds you mean business. So well-

## DADS in Compliance with Federal Aging Rules

With the departure of 42 year-old Domingo Ochoa from the Department of Aging and Disability Services (DADS), the agency is now in compliance with a federal law requiring that the average age of employees working for a state agency serving Medicare recipients must be 68 years or less.

"Domingo was a nice boy," said 83 year-old Eleanor Purvil, "but he didn't really fit in."

You're tellin' me," yelled Mr. Ochoa's 79 year-old manager, adjusting his hearing aide. "I couldn't understand a word he said. ## Governor-elect Abbott hurls accusations at Up The Enterprize. That's right, hurls!

On the heels of the Texas Sunset Commission's recommendation to consolidate the five-agency health and human services system into one mega commission, Governor-elect Greg Abbott has launched an investigation into allegations that Up The Enterprize (UpThe) knew about the pending abolishment of DADS well before the Commission's report was released last week.
