Board of School Trustees discussion and review of the Lyons Township Schools and Coop's financial records for May 2021. Treasurer Getty noted that reconciliations are completed through May 31, 2021, districts have healthy fund balances and there are no red flags.

NEW BUSINESS:

Acceptance of Trustee Kantas letter of resignation effective June 22, 2021

President Thiessen acknowledged the resignation by Trustee Kantas. He asked Treasurer Getty to post and publish the opening as soon as possible. The new Trustee will serve until the April 4, 2023, Consolidated Election. President Thiessen and Trustee Kirksey-Miller will review any letters of interest and resumes and will appoint an individual to fill the vacancy during a public meeting and prior to July 22, 2021. It was agreed to hold a meeting on July 15, 2021, at 1:30 P.M. for the purpose of appointing the new Trustee.

OLD BUSINESS:

<u>Semi-Annual Review of Closed Session Minutes</u> – This item was tabled until guidance is received from the LTTO attorney.

<u>Matters related to the possible withdrawal of Lyons Township High School District 204</u> from the Township Trustees of Schools, Township 38 North, Range 12 East, County of Cook, State of Illinois at the conclusion of FY2021

Treasurer Getty stated that he and the Trustees have received a letter dated June 25, 2021, formally notifying the LTTO that LTHS District 204 and their Board will be withdrawing from the LTTO effective July 1, 2021. He stated he intends to liquidate D204's positions in our investment portfolio and he expects that the majority of these funds will be in D204's possession on the morning of July 1, 2021. President Thiessen stated that the LTTO has 90 days to complete the transition and that communication with D204 will be key to ensuring an orderly and efficient withdrawal. Treasurer Getty stated that he anticipates having to have an additional interest distribution for FY21 due to the D204 liquidation. We are expecting an additional Accounts Payable run for D204 this week that will be dated June 30, 2021, and staff is working with their Business Office to do a "soft close" for June 30, 2021.
