Kilarney Amendments to Municipal Act Resolution

Councillor Gord Armstrong noted that Premiere Kathleen Wynne was in Rainy River Friday evening as part of the Métis canoe trip. He had the opportunity to speak to her briefly regarding some issues in our community.

Fire Board – Mayor Deb Ewald and Councillor Susan Carpenter

There was a board meeting in July. The old vehicles will need to be sold under the Town of Rainy River. Dennis Jodoin was supposed to provide some price information. Councillor Stamler noted that this might take some time but she will attempt to get the information required to list the vehicles.

Recreation Board/Curling Club – Mayor Deb Ewald with Councillor Susan Carpenter as alternate

Railroad Daze went well for the committee.

Currently there is a major cleaning and overhaul of the arena and painting of the facility.

The board is short a few members and will be seeking additional people. The next meeting is on September 11th.

Library Board - Councillor Gordon Prost

No meetings have been held recently; however, as a result of the recent articles in the paper they have received more donations (especially from residents of the Lake of the Woods and Dawson townships).

Locum House/Medical Centre - Mayor Deb Ewald and Councillor Pat White

The medical centre committee has met to propose that the lease amount calculated for April of 2017 be carried through until the end of 2019. They will also be given the option of taking over the cleaning contract. A note was made of the lack of transparency regarding their budget; however, they do not want to pursue this issue at this time.

The locum house committee had a meeting – everything is going well except for a few minor maintenance issues. As far as financials are concerned things are going well and there are no payments back to the communities as yet. Some other investment opportunities were discussed and will be pursued.

DSSAB Board Review

Species at Risk

Motion #17-107 - Larry Armstrong – Susan Carpenter

"With Respect to the Ministry of Natural Resources and Forestry (MNRF) planning to post a draft Species at Risk (SAR) Guide to the Environmental Registry for 28 species;

AND the MNRF has failed to consult and work with affected stakeholders and forestry dependent communities on the development of the draft SAR guide;

AND THAT municipal leaders have consistently requested the MNRF complete and share with municipality's socio-economic impact analysis on all policy impacting forestry;

AND THAT MNRF has conducted analysis for one prescription, caribou, and the analysis clearly demonstrates that mills will close;

AND THAT there has been no analysis of the cumulative socio-economic impact of all SAR rules contained within the guide (prescriptions) of multiple species;

AND THAT Ontario has world-class legislation, the Crown Forest Sustainability Act (CFSA), which provides balanced and sustainable forest management;

AND THAT the Endangered Species Act's (ESA) mandate of the protection and recovery of individual species at risk conflicts with the multi-species and multi-value approach of the CFSA, threatening forest sustainability;

AND THAT the government in 2007 committed to realizing CFSA equivalency to the ESA, acknowledging that the under the CFSA, the forest sector must implement SAR rules (prescriptions);

AND THAT even under a Section 55 Rules in Regulation "exemption", the forest sector must implement SAR rules (prescription);

AND THAT if the government continues to implement flawed ESA policy, mills will close, jobs will be lost, and forestry dependent communities will be decimated;

AND THAT the Town of Rainy River, in support of its hardworking citizens and the renewable forest sector, is prepared to work with government to avoid the unintended consequences of this ESA policy;

The Town of Rainy River calls upon the Government of Ontario to permanently delay the posting of the made-in-Ontario Species at Risk (SAR) Guide which contains prescriptions (rules) for 28 species by 2 years;

AND THAT with respect to caribou, the Government of Ontario immediately modify Ontario's proposed caribou prescription by moving the caribou range north to reflect animal collaring data,

moving away from the national 35% disturbance threshold, and acknowledging that other factors are threatening caribou recruitment and survival;

AND THAT the Government of Ontario support its forest sector and the 175,000 hardworking men and women, directly and indirectly, who live in communities in every region of the province by asking the Government of Canada to postpone the October 5, 2017 deadline for completing plans and acknowledging recovery could require timeframes in excess of 50 to 100 years,

AND THAT the Government of Ontario leave no worker, region or family behind by ensuring provincial policy supports at a minimum, current forestry operations and does not reduce the forest sector and its employment to a seasonal activity,

AND THAT the Government of Ontario extend the current Section 55 Regulation (exemption), which currently expires on June 30, 2018, for another 5 years recognizing that the CFSA ensure that all forest management in Ontario provides for all 3 pillars of sustainable development – economic, social and environment.

AND THAT any necessary by-laws be presented to Council for ratification. "

Prostate Cancer Awareness Month

"WHEREAS, prostate cancer is the most common cancer to affect Canadian men; and

WHEREAS, 1 in 7 Canadian men will be diagnosed with the disease in his lifetime; and

WHEREAS, an estimated 23,100 Canadian men will be diagnosed with prostate cancer this year; and

WHEREAS, the survival rate for prostate cancer can be over 90% when detected early; and

WHEREAS, those with a family history of the disease, or those of African or Caribbean descent, are at a greater risk of developing prostate cancer; and

WHEREAS, Prostate Cancer Canada recommends that men get a PSA test in their 40s to establish their baseline;

THEREFORE, I, Mayor Deborah Ewald, of the Rainy River, do hereby proclaim **September 2017 as Prostate Cancer Awareness Month** in Rainy River."
