THE 51st CONVENTION OF THE LCMS NORTH WISCONSIN DISTRICT THE CENTRAL WISCONSIN CONVENTION & EXPO CENTER ROTHSCHILD, WISCONSIN

June 7-8, 2015

CONVENTION THEME: "HE'S BY OUR SIDE"

The 50th convention of the LCMS North Wisconsin District opened with worship at 4:30 p.m. at Mount Olive Lutheran Church in Weston, WI. The message was delivered by the Rev. Dr. Matthew C. Harrison, Synod President.

SESSION #1 Sunday, June 7, 2015

1. CONVENING OF THE CONVENTION

President Lueck opened in the name of the Father, Son and Holy Spirit.

Vicar Tim Swanson reported a quorum (235/35) and the convention began.

- 3. Special thanks given to Rev. Daniel Thews for serving three terms as District Secretary and other Board of Directors of the past triennium.
- 4. Motion made and seconded to accept proposed convention agenda. Motion approved by voice vote.
- 5. President Lueck made some corrections to the convention workbook. Circuit counselors corrected. Church significant anniversaries corrected. Resolution 15-12 was added to registration packet.
- 6. D.J. Schult introduced the use of keypads and gave instructions for voting.
- 7. District President's report began with a video talking about postmodernism. President Lueck used this as a springboard to talk about truth and John 14:6 "I am the way and the truth and the life." Then introduced the synod mission statement and our North Wisconsin District mission statement. Then laid out the following challenges the NWD faces to its mission:

 - ii. The calling and retention of Pastors.

- iv. Engaging and equipping lay people for ministry.
- v. Reducing conflict among us.
- vi. Recruiting workers to serve.
- vii. Encouraging one another instead or tearing each other down.
