POLS 319: Legislative Politics Spring 2015

This course is a survey of what scholars know about legislative elections and legislative organization, with particular attention to the contemporary Congress. The focus is primarily descriptive and theoretic; the expectation is that legislative outcomes are the product of systematic calculation by goal-directed political actors.

Course requirements include three midterms and a final exam -- midterm 1 counts for 1/9th of your grade midterm 2 2/9ths, and midterms 3 and the final 3/9th each. Assigned readings for the course will be taken from *Analyzing Congress* (2<sup>nd</sup> Edition), available from the bookstore and the usual online sites.

I expect that you will attend each class, and come prepared to discuss the material assigned for each session. Excused absences require a compelling reason – serious illness, a personal crisis that <u>requires</u> your immediate attention, or official university business (e.g., an athletic event off-campus). If you want an excused absence, you need to provide documentation. I reserve the final decision on whether an absence is excused or unexcused.
