
The Tampa Bay Crimson

Our goal is to raise \$50,000 by August 15, 2015.






How can we get the word out and raise money for the endowment?

What's an endowment?

An endowment is a financial gift that creates a perpetual fund to provide scholarships. Scholarships are permanently provided with the money raised for the fund.

How can I contribute?

Donors may contribute via personal check, securities, real estate, charitable trust or annuity, insurance policy, testamentary gift or by employer's matching gift program payable to "The Alumni Fund."

Is my gift tax deductible?

Donations must be made directly to the Office of Alumni Affairs in order for the donor to receive an official receipt from the University for tax purposes. (Checks cannot be collected locally.) Some employers allow for educational donations to be matched.

How is the money invested?

All contributions received for the Tampa Bay Crimson Tide Endowed Scholarship Fund are invested in the UA System Pooled Endowment Fund. The University assumes responsibility for managing the fund, covering all administrative costs and investment charges.

Does the University match contributions?

Yes, annually, on or about June 30th, up to a certain percentage of all contributions made to the chapter's endowment fund may be matched by the Office of Alumni Affairs.

How will the scholarship be awarded once endowed?

After the fund is endowed, the value of the scholarship award is dependent upon the earnings generated from the investment of the endowment corpus.

As the principal value grows annually, the annual scholarship award from principal growth and donor contributions is likely to increase.
