The Child Protective Services Law requires all volunteers to complete three clearances, including the FBI Federal Criminal History Clearance. However, the Law includes a limited exception which exempts a prospective volunteer from the FBI clearance if both of the following conditions apply:

(1) the prospective volunteer has been a resident of Pennsylvania during the entirety of the previous ten-year period; and (2) the prospective volunteer swears or affirms in writing that he/she is not disqualified from service by reason of criminal history.

If you have lived outside Pennsylvania at any point during the prior ten (10) years, you are not eligible for the exemption and this Verification form does not apply to you. If properly completed, this Verification form will excuse eligible volunteers from the FBI Federal Criminal History Clearance.

Section 4305 (relating to dealing in infant children).
A felony offense under section 5902(b) (relating to prostitution and related offenses).
Section 5903(c) or (d) (relating to obscene and other sexual materials and performances).
Section 6301 (relating to corruption of minors).
Section 6312 (relating to sexual abuse of children).

SHEET 4 - PA FBI CLEARANCE - IF YOU ARE A PAID CHURCH EMPLOYEE AND HAVE LIVED IN PA FOR LESS THAN 10 YEARS:

FBI Fingerprint Clearance for ministry volunteers who have lived in Pennsylvania for LESS than 10 years Instructions for obtaining clearance:

- Applicants must register prior to getting fingerprinted at www.pa.cogentid.com or by phone at 1-888-439-2486
- Click the link on the top center row, “Pennsylvania Department of Public Welfare.”
- Click on the “Register Online” link.
- Applicants will pay a fee of \$27.50 (an additional charge of \$2 if applicant wants paper copy), payments must be made during registration online with a credit card.
- Print out Applicant Registration form with payment confirmation number.
- Applicant will bring approved State or Federal ID to fingerprinting site and all ten fingers are scanned to complete the process. The site location closest to Grace Chapel is The UPS Store 333 East Lancaster Ave, Wynnewood, PA 19096. Other locations can be found at www.pa.cogentid.com
- The applicant will receive the clearance form in the mail. When FBI Fingerprint Clearance is submitted to the GC Office you can request to be reimbursed for credit card charges. >> If you can sign the Disclosure Statement on the next page you DO NOT NEED to obtain FBI Fingerprint Clearance. Please print, sign and return the document to the GC Office.
