2019 \$.06 GAS TAX PLAN

WHEREAS, the 2019 Alabama legislature has passed an HB2 to levy additional excise tax on gasoline and diesel fuel, and;

WHEREAS, the Town of Eclectic is to receive a portion of said tax and;

WHEREAS, the Town of Eclectic pledges to keep this money in a separate fund and expend only for maintenance, improvement, replacement and construction of roads as mandated by the law passed, and;

WHEREAS, the Town of Eclectic is to adopt an annual transportation plan no later than August 31 for the next fiscal year based on an estimate of revenues.

NOW THEREFORE BE IT RESOLVED that the Town of Eclectic intends to spend the expected funds of +/- \$12,468 on projects listed on their transportation plan (see attached list.)

Adopted and approved on this the 19th day of August, 2019.




