### **CORRESPONDENCE FROM THE FISCAL OFFICER:**

Minutes from the January Regular Meeting being read prior by the Board were approved s read, so moved by Trustee Wolfe and seconded by Trustee Ellinger. All were in favor with 3 ayes and no negative votes, motion passed. Trustee Gail Ellinger motioned to accept the 2016 Township Highway System Mileage Certification for Hocking Township. As of December 31, 2016, Hocking Township was responsible for 31.846 miles of public roads. Motion was seconded by Trustee Steve Wolfe. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved. Trustee Gail Ellinger motioned to move from temporary to permanent appropriations. Motion was seconded by Trustee Steve Wolfe. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved. Fiscal Officer Ressler brought up the question on what to do with the broken down EMS unit. Trustee Wolfe motioned to have estimates done and not to expend more than \$10,000 for the repair. Trustee Ellinger seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved. Audit will be scheduled in the next couple months.

### **FIRE DEPARTMENT:**

Fire Chief Golden was absent for the meeting. Trustee Claypool spoke on his behalf. Total runs for the month were 33 EMS runs and 12 Fire runs. Year to date total is 81 EMS and 30 Fire. Mutual aid – Amanda 12 and Berne 7.

### **OLD BUSINESS:**

1. AEP with whom we have a RUMA with will be repairing the road this year.
2. Mr. Pat Marshall of Country Club Road is getting gas lines to his home and then onto lots that will be sold off. The Township has not heard back from Nate Wagner for setting up a RUMA.
3. ODA held a public meeting at the township building for the Gypsy Moth procedure this year. There was one resident that attended.
4. Trustee Ellinger and Fiscal Officer Ressler attended the Annual OTA Winter Conference. Very informational.
