**NOW, THEREFORE BE IT RESOLVED** that the stated request be forwarded to the Montgomery County Auditor.


Trustee Back seconded the motion, and the roll was called on the question of its adoption.



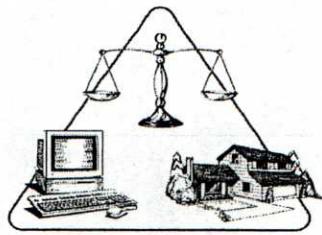
