MORE THAN SPORTS WAIVER FORM

IN ORDER TO BECOME ELIGIBLE TO PARTICIPATE IN **MORE THAN SPORTS**, YOU MUST SIGN THE FORM BELOW AND SUBMIT TO LEAGUE DIRECTOR BEFORE PARTICIPATING.

IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN ANY WAY, IN ANY **MORE THAN SPORTS** LEAGUE, EVENTS, OR ACTIVITIES, I UNDERSTAND, ACKNOWLEDGE AND AGREE TO THE FOLLOWING:

1. I CERTIFY THAT I AM PHYSICALLY FIT AND ABLE TO PARTICIPATE IN THE LEAGUE, EVENTS OR ACTIVITIES, AND HAVE NOT BEEN ADVISED OTHERWISE BY A QUALIFIED MEDICAL PROFESSIONAL.
2. I AGREE TO COMPLY WITH ANY AND ALL RULES, REGULATIONS, TERMS AND CONDITIONS FOR PARTICIPATION IN THE LEAGUE, EVENTS OR ACTIVITIES. I AGREE TO INSPECT THE EQUIPMENT AND PREMISES TO BE USED PRIOR TO PARTICIPATION. IF I BELIEVE THAT ANYTHING IS UNSAFE, I WILL INFORM LEAGUE DIRECTOR, GAME OFFICIALS, TEAM CAPTAIN, OR FACILITIES OWNERS OF THE ISSUE AND WILL REFUSE TO PARTICIPATE IF NOT CORRECTED.
3. I ACKNOWLEDGE AND FULLY UNDERSTAND THAT AS A PARTICIPANT, I WILL BE ENGAGING IN ACTIVITIES THAT INVOLVE RISK OF SERIOUS INJURY, INCLUDING PERMANENT DISABILITY AND DEATH, PROPERTY LOSS AND SEVERE SOCIAL AND ECONOMIC LOSSES. THESE RISKS INCLUDE, BUT ARE NOT LIMITED TO, THOSE CAUSED BY: (A) THE ACTIONS, INACTIONS OR NEGLIGENCE OF **MORE THAN SPORTS** LEAGUES, PARTICIPANTS, VOLUNTEERS, SPECTATORS, COACHES, EVENT OFFICIALS, GAME OFFICIALS, EMPLOYEES AND ORGANIZERS; (B) CONDITIONS OF THE PREMISES OR EQUIPMENT USED; (C) RULES OF PLAY; (D) TEMPERATURE; (E) WEATHER; (F) CONDITION OF PARTICIPANTS; AND, (G) VEHICULAR TRAFFIC. I FURTHER ACKNOWLEDGE AND FULLY UNDERSTAND THAT THERE MAY ALSO BE OTHER RISKS THAT ARE NOT KNOWN OR FORESEEABLE AT THIS TIME. **I KNOWINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS, EVEN IF ARISING FROM THE NEGLIGENCE OF MORE THAN SPORTS OR OTHERS, AND I ASSUME FULL RESPONSIBILITY AND LIABILITY FOR MY PARTICIPATION.**
4. I, ON BEHALF OF MYSELF, MY HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS, HEREBY WAIVE, RELEASE, DISCHARGE, AND AGREE NOT TO SUE **MORE THAN SPORTS**, ITS DIRECTOR, MEMBERS, OFFICERS, EMPLOYEES, VOLUNTEERS, REPRESENTATIVES, AGENTS, COACHES AND GAME OFFICIALS,
5. AND OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS AND IF APPLICABLE, OWNERS AND LESSOR OF EQUIPMENT AND PREMISES USED TO CONDUCT THE LEAGUE, EVENTS OR ACTIVITIES (COLLECTIVELY **MORE THAN SPORTS**), FROM ANY AND ALL CLAIMS FOR DAMAGES, INJURIES, LOSSES, LIABILITIES AND EXPENSES WHICH I MAY HAVE OR WHICH MAY SUBSEQUENTLY ACCRUE TO ME, RELATING TO, RESULTING FROM OR ARISING OUT OF MY USE AND/OR PARTICIPATION IN ANY PROGRAMS, EVENTS OR ACTIVITIES OF

MORE THAN SPORTS, INCLUDING ANY INJURY OR DAMAGE TO MYSELF OR MY PROPERTY, OR TO THAT OF ANY OTHER PERSON OR PROPERTY.

6. I AGREE TO INDEMNIFY, DEFEND AND HOLD **MORE THAN SPORTS** HARMLESS FROM AND AGAINST ANY AND ALL CLAIMS FOR DAMAGES, INJURIES, LOSSES, LIABILITIES AND EXPENSES RELATING TO, RESULTING FROM OR ARISING OUT OF MY PARTICIPATION IN ANY **MORE THAN SPORTS** LEAGUE, EVENT OR ACTIVITY.
7. I CONSENT TO HAVE MEDICAL TREATMENT THAT MAY BE DEEMED ADVISABLE IN THE EVENT OF INJURY, ACCIDENT AND/OR ILLNESS DURING ANY PROGRAM, EVENT OR ACTIVITY. I RELEASE **MORE THAN SPORTS** AND ALL PERSONS PARTICIPATING IN ANY SUCH MEDICAL TREATMENT FROM ALL RESPONSIBILITY FOR ANY SUCH ACTIONS.
8. I INTEND THAT THIS WAIVER AND RELEASE OF LIABILITY SHALL BE CONSTRUED BROADLY TO PROVIDE A RELEASE AND WAIVER TO THE MAXIMUM EXTENT PERMISSIBLE UNDER APPLICABLE LAW.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT FULLY. I UNDERSTAND ITS TERMS AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INCENTIVE, BRIBE OR INDUCEMENT.
