

VILLAGE OF CALUMET PARK REGULAR BOARD MEETING
March 24, 2022, SESSION #366 VIA ELECTRONIC COMMUNICATION

Minutes of the Regular Board Meeting of the Board of Trustees of the Village of Calumet Park, Cook County, Illinois, held in the Council Room of the Buster B. Porch Municipal Complex, 12409 South Throop Street. Calumet Park, Illinois on the 24th day of March, 2022.

Chaplain Ross spoke on the rescheduled Church Alliance meeting.


Mayor Ronald Denson asked for any citizens concerns, one spoke concerning a neighbor situation.
