- -Mike Dennis has someone interested in purchasing the town truck and plow. The board has asked that they make the Village an offer.

- -Haar stated that the NE and NW corners of Paul and 10th Streets are in need of rock. Brandon Keller will be contacted to haul it.

-Trone presented to the board prices on baseball equipment for the two (2) ball diamonds in Coleman Park. Cost for boys diamond is: \$260.80
