# **BRANCH MEETING** July 15, 2020

At 1905 President Kaider convened an informal meeting with 6 members present including NC Paul Gunther, Jr. Past President Thomas Rauch, Shipmate Ralph Freibert, Shipmate Jerry Iseminger and Shipmate Mark Allen. We held our meeting via Zoom because of COVID-19 restrictions.

The meeting started with the Report of Committees. Shipmate Kaider had nothing new to report for Youth Activities. Shipmate Gunther reported that the 2020 Americanism & Patriotism essay contest has started and this year's topic is "The Bill of Rights and Me". The Branch Secretary should be receiving essay posters and rules from Headquarters for distribution. NOTE: Since the meeting Branch Secretary received posters and sent to Shipmate Gunther.

No report from Hospitals, Welfare, and Rehabilitation and Shipmate Kaider reported that as of July we have 83 members. Also reviewed the July FRA Membership Newsletter from Headquarters, which will be distribute with this newsletter via e-mail.

The July Financial Statement was submitted by Shipmate Rauch and motion was made for approval, it was seconded and approved by all.

Shipmate Rauch reported that he received NED Memo 4-20 (Postponement of 93ra FRA National Convention and Call for Nominations), it briefly states that the National Convention has been postponed until September 25, 2021 and will be held in Portland, OR. Chief Petty Officer Floyd W Goddard, USN (Ret) July 10, 1930 - February 20, 2020

Shipmate Goddard was a FRA Member of 47 years. A Retired Chief Navy Corpsman with over 20 years enlisted on 3 Naval ships and Korean War Active Duty with Marines Corps. Military duty brought him and his family from Boston to Florida in 1965. After Navy retirement Floyd spent most of his working career at Jess Parrish

Memorial Hospital, specialized in hematology and chemistry eventually leading the laboratory department until retiring in 1988.
