

## MORNING SHOW

My late husband, Vic and I enjoyed Field Trials with our Brittany's in the early 50's. At our first dog show in 1954, we won a five point major with our Brittany puppy. From that time on, dog shows were a way of life for us. Our Brittany finished her Championship, as did her son. We felt it would challenge to finish a home-bred champion in each of the remaining groups. This goal was achieved, over a thirty year time span, with the following breeds: Brittany, Wirehaired Dachshund, Boxer, Miniature Schnauzer, Miniature Pinscher, Bichon Frise and Pembroke Welsh Corgi.

I served as my husband's assistant when he became a Licensed All-Breed Handler. In 1977 we retired from handling and applied for judging approval. I am approved to judge the Sporting, Hound, Working, Terrier, Toy and Non-Sporting Groups and Best In Show. I am on the Board of Directors of the American Dog Show Judges.

I have had many wonderful experiences having judged in Australia, New Zealand, South Africa, South America, Canada, Mexico and all of the 50 states. Judging the Terrier Group at Westminster in 2010 was a great honor and privilege and the highlight of my judging career.

I was born in New Jersey, moving to Tucson, Arizona as a child in 1958 at which time my family met and acquired our first Boxer. I grew up with this wonderful breed, and was involved in Junior Showmanship. Soon after college I rescued my first Great Dane Bitch, who introduced me to the breed I would become best known for. Under the prefix "Del Oro" we bred seven generations of Specialty and Group Winning Fawn and Brindle Great Danes.

I have served as the President of the Great Dane Club of America, and continue on the GDCA Board today chairing both the Judge's Education and Ethics Committees. I have judged the GDCA National Specialty four times, the Top Twenty Invitational three, and National Specialties in four countries. I was first approved to judge Great Danes in 1984, achieving approval for Boxers the following year. Thirteen years ago my husband and best friend John Jarvise and I added Whippets to our lives. We have been most fortunate to have had a Whippet in the Top 20 for three years, and co- own GCh. Bo-bett Tivio Man of Steel, who was the #1 male in the country three years ago.

Dogs are our lives, and we are grateful to the many friends and colleagues we have met along the way. I am also very grateful to all of you, who dedicate yourselves as breeders, exhibitors and fanciers to the wonderful Boxer breed, and have entered this specialty today. My thanks to the Arizona Boxer Club for the privilege of judging this show.
