"BLUE WAVE" NOVEMBER FORECAST

Should the Town give tax breaks to certain individuals?

For instance, a town deputy supervisor owns a residential property on the river that was assessed for \$4,266,100 in 2012. The assessment was lowered 24.9% to \$3,200,000 in 2013. The property is now listed for sale with an asking price of \$6,500,000. A neighbor of the deputy supervisor, and business colleague of the town supervisor, owns a residential property on the river that was assessed for \$824,300 in 2012. The assessment was lowered 18.9% to \$668,300 in 2013. The average residential property assessment in the same tax zone increased by 21.6% between 2012 and 2018. In lowering the assessments on these two properties, the town government shifted tax burdens totaling \$154,241 (town, county, school district) to other taxpayers.

Nutshell Review of Town's Tentative 2019 Budget

The County just announced it's 5th straight year of tax reductions and the Town announced it's 5th straight year of core government tax increases. 70% of the County budget goes to external mandates while just 10% of the Town core government budget goes to external mandates. So far the Town core budget less mandates has gone up 12.5% in five years. Inflation or tax caps totals 6% over the same period. Much of the excess 6.5% can be attributed to 29.6% increase in employees' and officials' compensation. The value of properties in the Village have gone up 3.4% and the Town levies on these properties have gone up 36.4%. Property values outside of the Village have gone up 5.6% while associated levies have gone up just 8.4%.
