


SOUTHWYCK CAI - ANNUAL MEETING - RESULTS OF ELECTION

I hope everyone had a Merry Christmas and a Happy New Years and beyond. "Stronger Together"



While we are out and about and talking to members of our association, we sometimes find that some folks are a bit confused about our association.



STARTING THIS YEAR, 2017, WE ARE GOING TO A QUARTERLY NEWSLETTER




ARE YOU CONFUSED ABOUT YOUR ASSOCIATION?

Our community, Southwyck, is organized by 2 entities. The first entity is Southwyck CAI (sometimes known as the master) AND then there is the Section head entity. Your village is managed by section heads of Section 1, 4 and 5.

Section 1 covers Southglen & Emerald Pointe which is sections 1, 2 & 3. They control a pool, open field, 2 play grounds and all ARC related issues including sending letters regarding ARC issues. Section 4 covers Southmanor, Edgewater Estates, Southfield Village and Huntington Park and those are Sections 4, 7, 8 & 9. They control a pool, a baseball field, 1 playground and all ARC related issues including sending letters regarding ARC issues. Section 5 covers Lakecrest Estates and is Section 5 only. They do not have a pool but they do have a landing pad at the lake and all ARC related issues including sending letters regarding ARC issues. The image below was created to help you figure out which specific village you should be contacting for village

inquiries and which association handles what. Village names are given next to each section that heads those villages and section numbers are displayed within the blue circles in case you do not know what your village name is. Do you want to know who to call about a deed violation letter you got? Go to your section head or find your village name next to one of the section head circles and that is who you contact. Want to know what the pool schedule is for the Morgan road pool? Find Morgan Rd in the Section 4 circle and that is who you contact. Want to reserve the Southwyck Lake Park pavilion? That is under the Southwyck Community Assoc. header so Southwyck CAI takes care of those reservations. Should you be contacting Southwyck CAI about any pool issues? No..... We do not have a pool and do not handle any pool issues. Sections 1 & 4 have pools. If you go to www. SouthwyckTexas.com you can find the contact information for all associations there as well.






that if you want to know what went on at our monthly board meeting you were unable to attend, you need to visit the ONLY site that your HOA controls and directs their full attention to, www. SouthwyckTexas.com. Take a look at the 'News & Events' page, where you will find we update this page and our website regularly. The Southwyck CAI board, just like many other neighboring associations, has an official website where information can be found about our association. The Southwyck CAI board does not monitor on a regular basis, social media sites. If you want information about our association, visit our website and see if the information is addressed there and if it is not; fill out the 'Contact Us' form on the 'About Us' page on the right-hand side. This form and the information you enter on it goes directly to the Southwyck CAI board members only. We usually can address your concerns within less than 24 hours. Sometimes it is just minutes. You will find lots of good information at our official site, so take some time to check out the pages and links. We also keep our latest newsletter under 'Records/Minutes/ Newsletter/Presentations' page. Of course, you are always welcome to come to a monthly meeting to also find out what is going on in our association. We try to always reserve the first 30 minutes of each meeting to hearing what homeowners have to say. You are welcome to come, ask a question, hear what we are working on and stay up until the executive session. You can leave at any time in-between too.

We enjoy meeting the homeowners in our community and having them join us at our meetings.

GET READY FOR THE NEW YEAR

Spring will be here before you know it. With the beginning of the New Year, we strive to break bad habits and start good ones, so plan the next couple of months for home repairs, upkeep or locating contractors to help do the work for you. You DO NOT want to get one of those pesky letters from your Section head, so find a contractor for lawn care, tree trimmers and power washers for your driveway and/or house if you do not want to do them yourselves. You could get letters from your HOA if you leave out your recycle bin, park a boat, disabled vehicle, trailer or pod on your street, in your yard or on your driveway if they are left for any significant period of time. Not to mention that some of these left on the street make for hazards for drivers when they cannot see around them. Is it time to repaint your house or refurbish your front door? Find out who does good, reputable work from neighbors or some of the social media sites for our area. Is the basketball stand looking shabby and is anyone actually using it anymore? Maybe it's time to see if anyone else wants it. Check out the Freecycle organization, https://groups.freecycle.org/group/PearlandTX/ posts/all or on Facebook, (BUY, SELL, TRADE SALE) Pearland, Alvin, Manvel, Friendswood, South Houston (this is a Closed Group, so you have to request invite) to see if someone else needs something you need to free from your house. There is always Craigslist as well. Remember, you can use the Pearland Police Department's parking lot on Cullen to make the exchange safely. FREE YOUR HOME of unneeded 'stuff' and get those home repairs done before it gets too hot. Summer is just around the corner and do you really want to be tackling these jobs then?!



that the master part of our association DOES NOT handle any ARC issues? Your village section

head does and they send out the deed violation letters. If you live in SOUTHGLEN or EMERALD POINTE your section head is Section 1. They take care of Sections 1, 2 & 3.

Section 4 covers the villages of SOUTHFIELD VILLAGE, SOUTHMANOR, EDGEWATER ESTATES


AND HUNTING PARK and this includes Sections 4, 7, 8 & 9.

Section 5 covers the village of Lakecrest Estates and is only Section 5.

By learning where you live and who your section head is, you can speed up making contact with the correct entity. The board always tries to help find an answer and get back to you as quickly as possible. The fastest way of contacting the master board is through our alias, directors@southwycktexas.com, which you can also see at our website, www.SouthwyckTexas.com should you forget. ALL board members will receive your email. If the answer needs to come from a section village head, we will send your email on to them to answer and hopefully they will answer you back just as quickly as we do.

TOP 3 ISSUES CMSI MANAGEMENT COMPANY GETS CALLS ABOUT

- 1. Deed violation issues which we have mentioned, need to be addressed by the section that represents you.
- 2. Requests for waiver of late costs/I never got any bills.
- 3. Pool issues or access cards again, the section head that represents you needs to be contacted.

SHOULD YOU GO TO AN EMERGENCY ROOM OR AN URGENT CARE CENTER


It seems like there is an emergency or urgent care center at every other corner in Pearland. It makes you wonder if our community is that ill or what. It is important to know the difference between emergency rooms and urgent care centers given that there is one at nearly every other block. Emergency centers provide medical care at any time, day or night. They are equipped with staff for even the most complex or critical needs, including life and limb threatening situations ranging for heart attack, stroke, traumatic injuries from a car accident and severe burns. They can provide x-rays and surgical procedures. The ER costs an average of three times more than a visit to the urgent care. The wait time can be several hours. Urgent care centers are not an emergency care centers, but are a valid bridge between your primary care physician

and emergency room services. Urgent cares are equipped to handle non-life threatening situations that you can typically find at your doctor's office. This can include fever, flu symptoms, ear infections, allergic reactions, minor cuts, bronchitis, urinary tract infections, animal bites and sprains and broken bones. Most are open late and on weekends and holidays. They are a great resource when you need immediate care but cannot get in to see your doctor or do not have time to wait to get in to see your doctor. Urgent care centers are far better for time and cost. You are generally seen on a firstcome, first-serve basis and usually average less than 30 minutes from the time you arrive to the time you depart. The problem is that some ailments and symptoms straddle the line and only a trained medical staffer could make the call. The following estimated costs were prepared by Medical Choice Network for nine of the most common reasons people visit the ER. They were determined by calculating the average number of claims submitted in 2010 to the Medica Choice Network, a system of more than 4,000 medical offices, clinics and hospitals across four Midwestern states.



HOME REPAIRS – THERE'S A VIDEO FOR JUST ABOUT EVERYTHING


To those who think they cannot tackle some simple home repair tasks, you may be wrong! When it comes to home repairs, get the kids involved too. They need to know they can handle simple home




repair jobs too. I never worried about failing at one of these home repair jobs when I did them with my kids. We all learned something if what NOT to do the next time. My daughter knows how to install a ceiling fan and knows what some of the pitfalls are and is prepared for them all because I included her in on installations. We have had some 'interesting' laughable moments working together on some of these household repairs and it sure helps to have a sense of humor instead of cussing and throwing tools around. You can find all kinds of videos on how to do some of the simplest home repairs. I usually start on YouTube.com and enter a phrase on what I'm trying to do in the search box. I have also found some good Facebook pages like 'The Family Handyman' or 'Home Show Radio' with local, Tom Tynan (also, homeshowradio.com) and they are now on my Facebook feeds.

The nice thing about any online videos is that you can review them over and over again and stop

in the middle of one to do a part of the task and then continue on viewing until you need to catch up again. Take a look at different videos for the same task to see if someone else explains it better or has a trick that helps. You can sometimes save yourself lots of money if you just tackle some of these extremely simple home repairs yourself and how rewarding is it to know you were able to do it yourself or with the kids or spouse's help. I would not expect to have the 5 year old to be of much help, but for sure, your teenagers should be able to assist. Just remember, redoing your work over again is OK. Hold your tongue and laugh off not getting it perfect the first time. Even if you do not think you can do it yourself or want to do it yourself, you are at least educating yourself on what it could take to do the job and may learn something that makes you more knowledgeable when discussing the job with a contractor.


