## I. President's Report - Steve Freeman

A. A Self-fulfilling Prophecy?

At the September 23 meeting of the Board of Education district COO Michael DeVito presented his Multi-Year Financial Plan. As expected it was a tale of gloom and doom; projecting an almost \$3mil deficit for the 2016-17 school year. Yet his words had a hollow ring when it was he who crafted three consecutive operating budgets which called for 0% increases in the tax rate. One does not have to be a professor of economics to know that a deficit results from increased spending with no corresponding increase in revenue.

- B. Attendance at Board of Education Meetings We are asking every association member to attend at least one Board of Education meeting this year. Your reps have posted sign-up sheets. Upcoming Board meetings are scheduled for October 28 (MS), November 25 (MS) and December 9 (East). The meetings start at 7:30 PM and usually last for about two hours.
- C. First Eligible Retirement Incentive

If you are considering retiring next June under the terms of our first eligible retirement incentive; you must notify the district of your intention by January 15, 2015. First eligible means that you are able to retire without an age or service reduction. You do not have to use time awarded under Article 19 to determine eligibility. If you are unsure if you are first eligible, or need more information, please contact me a.s.a.p.

D. Salary/Sick Bank Statements

Annual salary/sick bank statements will be distributed on October 24. I recommend that you confirm that the number of days in your sick bank are correct. Keep in mind that the statements include this year's 12 days, plus up to two additional days if you worked at the 2014 summer school. Contractually you cannot keep more than 200 days in your sick bank. Any days in excess of 200 should be sold back (restrictions apply) or you will lose them. With regard to salaries; keep in mind that we are still in negotiations. Therefore the 2011-12 salary schedule still applies.

- E. Flex Plan 2015 The Affordable Care Act limits flexible spending account contributions for excess medical expenses to \$2,550 per year. Child/Elder care spending limits continue to be \$5,000 per year. Forms and more information will be sent to you via an e-mail from Laurie Sarro on November 3. In addition paper copies should be available in all of the main offices. Keep in mind that your 2015 declarations must be received by the Human Resources Department on December 1, 2014.
- F. Services for English Language Learners The Board of Regents has adopted sweeping changes to Part 154 of the Commissioner's Regulations with regard to ELLs, effective October 1, 2014. We are currently researching the impact of these changes on the membership including the mandate that beginning in September 2015 the district must offer bi-lingual classes if there are 20 or more ELLs at the same grade level district-wide who speak the same home language. Such teachers must be certified in Bi-lingual Education and a new tenure area created. A NYSUT created fact sheet explaining the changes is attached.
- G. Field Trip Costs

As per the Board of Education's Field Trips policy every student has the right to attend a field trip no matter the student's ability to pay. Therefore it is the district's responsibility to ensure that funds are available for those in need. Should you be asked to "donate" or be required to pay for students to attend please contact me a.s.a.p.



- Π. Chief Negotiator's Report - Steve Freeman
  - Α. Exec VP Harvey and I met with Supt Weiss on October 8 to discuss the status of negotiations which abruptly broke down on June 18. It was decided that we should make one more attempt at a settlement before requesting the assistance of a Super-Conciliator. We will be meeting with the district on October 30 at 4 PM in the MS Library.



Β. Flashback to 1982

In 1982 the association and the district had reached an impasse in negotiations. The association presented evidence to the fact finder that the district ended the previous year with a surplus of almost \$3 mil or 11% of the then current budget. For the past 32 years it has never been a shortage of funds which has precluded fair contract settlements. Rather it is an institutionalized unwillingness; independent of who serves on the Board or leads the district. Changing that culture is the key to our long-term financial well-being.

Β. **Related settlements** 

> Since negotiations began in 2012 the District COO Michael DeVito's mantra has been "no money on the salary schedules and no raises in excess of the tax cap." At its October 14 meeting the Board of Education approved raises for district administrators and unaffiliated employees which are not only on schedule but also pierce the cap: District COO Michael DeVito - 2%

D. APPR

Teachers not receiving a *State Provided Growth Score* for their APPR should be working in collaboration with an administrator to compete an SLO template. This does not mean that you are required to fill out the SLO template or supply the data for it. It is ultimately the district's responsibility to complete the SLO. However I would advise you to take an active role in the process. Once you have determined your baseline and evidence you should begin work on your targets. If you choose not to participate in the creation of the SLO one will imposed.

- E. Biometric Signatures/Timepiece Although the secondary schools are no longer using paper sign-in sheets it was once again presented that the elementary schools are still using paper sign-in sheets and some have no intention of switching to Timepiece alone.
- F. Grievance Committee

NIKE Health and Safety - The intercoms and key fob locks on the front door have been installed and minor calibrating is required to finalize the installation. If they are not already operational, they will be shortly.

Lido School Locked Storage -All classrooms have locked storage.

Health Insurance Withdrawal - Thank you to Trustees Mininski and Vrona for taking the time to hear this Stage III grievance. The Board has requested to "Stop the Clock" so that they can better understand the problem and discuss a possible solution. Under the terms and conditions of our previous contract settlement we agreed to change from a 50% withdrawal sellback to a flat rate. Sometime shortly after the settlement the district unilaterally decided that they wanted to keep some of the old language and create multiple flat rates. As a result the rate of \$6,708 annually for pre-7/1/09 members and \$4,000 annually for post-7/1/09 members was not paid to all members who sold back their health insurance.

Extra Teaching Assignments at the High School- There has been a complaint that approximately 12 high school teachers were unilaterally assigned an additional class and are not being compensated for the extra class. We are discussing a possible solution with Superintendent and look forward to resolving this without a grievance being filed.

- III. Vice-President for Elementary Schools' Report Beth Prostick
  - A. Unfortunately, our new report cards will not be ready for the first trimester marking period. We will be using the same report cards as last year for the first trimester.

- IV. Vice President for Secondary Schools' Report Karen Bloom
  - A. We are still having difficulty defining common planning time at the high school. There is very limited time for teachers to meet to plan for their respective courses. It is extremely difficult to accomplish this when some directors are taking our common planning times to have meetings about departmental issues that could easily be discussed at department meetings. This problem is compounded for those teachers on a team who need to meet 3 days a week with their teams. The other two days are being taken by our directors.

- B. There are a number of inclusion classes, especially in 9th grade, that have very high numbers of special education students. Some have 12 students with IEP's. This does not even include those students with 504s or other behavioral issues. This does not provide for an environment that is conducive to learning, and makes it next to impossible to meet the needs of all students in the rooms.
- C. Although we clarified the types of AIS last year and shared this information with the new Director, of STEM; Dr. Lovrich has created a situation in which we have two completely different classes being taught simultaneous in one classroom. One group of students are there for support and the other group are there for Regents Prep. Dr. Newman is trying to rectify the situation so that the disparate needs of these students can be met.
- D. We are still having technology issues at the HS. The computer labs need to be monitored more closely in order to deal with the many issues that arise on a daily basis. We also need more computer labs, laptop carts and iPads in order to more effectively integrate technology into our lessons.
- E. We are still awaiting clarification on the APPR targets and procedures for this school year. Dr. Graham has assured me that he will more closely oversee the curriculum directors to ensure that there is more consistency among the departments.
- F. We are hopeful that the district will remedy the situation with the science teachers in the high school who are teaching more than the required teaching load in a given semester. We are also optimistic that the district will implement some of the suggestions offered for next year so we can avoid this situation in the future.
- G. The traffic pattern at the high school is still a major problem. Having buses exit the direction that students, parents and teachers are entering is extremely dangerous and causes a major back-up. This delay becomes a problem for students and teachers who have a first period class as it can take up to 20 minutes to get from Lido Blvd. to the high school entrance. We hope that this will be revisited in order to rectify the many problems that are being caused by this pattern.
