MUTTON BUSTIN' REQUIREMENTS

Pre-Registration can be mailed to Trinity County Fair, post marked by September 9, 2022, with \$10 Fee and Registration/Liability Waiver Form.

Same Day Registration, 6pm at the Main Arena, Trinity County Fairgrounds.

The first 30 Registered Contestants will be in the Event.

Fee: \$10 per Contestant (100% Pay Out)

Age Limit: 5 – 9 years old (as of September 1, 2022)

Weight Limit: 60lbs

Attire: Participants must wear long pants, long sleeve shirts, shoes or boots (no sandals)

Helmets: Participants must wear and provide their own helmets (bicycle/hockey style helmets are ok)
No Racing Helmets with pointed fronts.

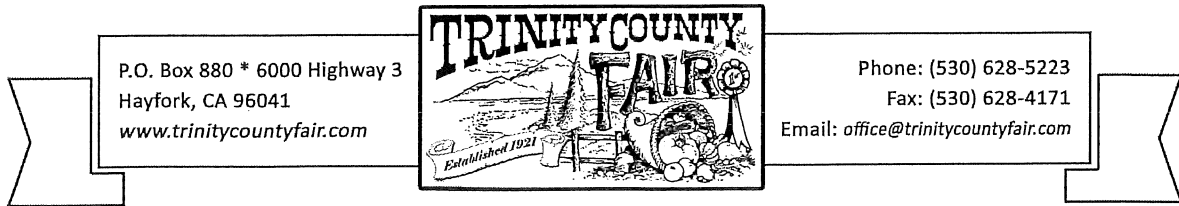
Check-In: 6:30pm Main Arena Registration Table
