There being a quorum, Mayor Penrod called the meeting of the Vienna City Council to order at 6:30 p.m.

NEW BUSINESS

Alderman Hill made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the November 3, 2021 council meeting minutes, the Warrant (\$65,951.36), and Treasurer's Report. Alderman Pitts seconded the motion. All in favor motion carried.

Hill made a motion to Authorize and Approve to increase the amount for the purchase of water and fruit for the 50/100 run. Increase from \$700.00 to \$948.00 (Tourism Funds). Alderman Racey seconded the motion. All in favor motion carried.

Alderman Moore made a motion to Authorize and Approve TIF Funds in the amount of \$20,000.00 for gas line relocation concerning future 146 East project. Alderman Tuey seconded the motion. All in favor, motion carried.

Penrod noted that discussion of the nuisance ordinance revision would be tabled until the December 1, 2021 meeting.

PUBLIC COMMENT

Phil Morris was present to update the council on the recent 50/100 mile run. Morris said the event was successful and thanked volunteers and organizations that helped with the event. Morris presented city park employee, Wendell Clardy, with a certificate for his outstanding work over the weekend. Morris said Clardy went above and beyond his duties to help with the run. Mayor Penrod also commented on the run thanking the council for their help. Penrod also mentioned speaking with the race director of imposing a small parking fee for future runs. Alderman Racey thanked the Mason's Lodge for providing the dinner at V.H.S and food overnight for the runners. Racey also thanked Vienna Police Department and Johnson County for directing traffic.

ELECTED/APPOINTED OFFICIALS

Supt Racey informed council that a military truck and two flatbed trailers were no longer being utilized by public works. Racey said he would like to request sealed bids to sell the items. Racey also said a sewer line issue on Hess Street had been resolved.

Alderman Pitts commented on parking for the 100-mile run, noting equipment needs for future events.

Alderman Tuey informed council that after responding to a recent call, the Fire Department was in need of extra color-coded hoses. Tuey requested the item be placed on the next agenda.

Alderman Hill commented on the holiday meal Margaret Mathis hosted for city employees at the library. Council members also expressed appreciation for the meal.


Mayor Penrod said he discussed fire call collection invoicing with Chief Williams, reviewing a final notice draft. Penrod said final notices would be sent after a first and second notice to collect, which would give a total of ninety days. After ninety days, the city would take legal action on unpaid invoices.

Penrod reviewed a quote from L&P Carpet, Inc. on replacing city hall flooring in the amount of \$17,732.00, including materials and labor. Council discussed getting additional quotes and what portion of the labor public works could perform to save money. Painting of city hall walls was also discussed.


As there was no further business to discuss Alderman Pitts made a motion to adjourn the meeting. Alderman Owen seconded the motion. Motion carried.

Mayor Penrod declared the meeting adjourned at 7:23 p.m.
