3. Citizens who wish to address the Board:

1. Robert MacDonald addressed the Township Board regarding conditions of Lots 1 &2 in River Ridge. The lots were not cut properly, long grass, weeds, etc. still remain. Supervisor Mahaffy will look at property.

2. Dan Miller commented on new trash cans on bike path & property in Industrial Park.

4. Paul Dingeman, Cable Channel 6 addressed the Township Board regarding use of franchise fees from Comcast. He informed board that a possible merger will happen in the near future. Moved by Trustee Hanrahan, supported by Trustee Mollan to continue franchise contract with Cable Channel 6 for the next fiscal year or until a merger change occurs. 5. Moved by Treasurer Miskus. Seconded by Clerk Skonieczny to amend the 2013-2014 General Fund & Inspection Fund Budget. Roll Call: Yes-Trustees Boulrier, Boeck, Hanrahan, Mollan, Treasurer Miskus, Clerk Skonieczny & Supervisor Mahaffy. (Attached) Motion Carried.

6. Moved by Clerk Skonieczny. Seconded by Trustee Boeck to contract with the St. Clair County Road Commission for the following:

- a. Ditch south side of Kennedy Road approximately 600 feet at a cost of \$8000.00.
- b. Ditch north side of Vine Road starting at Kennedy approximately 600 feet at a cost of \$4000.00.
- c. Ditch west side of Allington starting at cross road culvert approximately 400 feet at a cost of \$3000.00.
- d. Remove & replace cross road culvert on Stein Road at a cost of \$4000.00
