APPLICATION FOR ELECTRICAL WIRING PERMIT

PER WYOMING STATE STATUTES
AN ELECTRICAL WIRING PERMIT FEE IS \$50.00.

PLEASE MAKE CHECKS OR MONEY ORDERS PAYABLE TO THE STATE OF WYOMING.

THE ENCLOSED APPLICATION AND FEES SHALL BE SUBMITTED TO THE DEPARTMENT OF FIRE PREVENTION AND ELECTRICAL SAFETY IN ORDER TO RECEIVE AN ELECTRICAL WIRING PERMIT. ONCE OUR OFFICE HAS RECEIVED THE APPLICATION AND THE \$50.00 PERMIT FEE, A PERMIT AND RECEIPT WILL BE ISSUED TO YOU. IT IS YOUR RESPONSIBILITY TO CALL YOUR LOCAL POWER COMPANY AFTER YOU HAVE RECEIVED THE PERMIT FOR POWER HOOK UP. NOT UNTIL YOU HAVE RECEIVED THE PERMIT AND RECEIPT SHALL ANY ELECTRICAL INSTALLATION BEGIN.

PLEASE NOTE: IF TEMPORARY POWER IS NEEDED, TWO PERMITS WILL HAVE TO BE PAID FOR. ONE FOR THE TEMPORARY HOOK UP AND ONE PERMIT PRIOR TO STARTING ELECTRICAL INSTALLATION OF STRUCTURE.

THE DEPARTMENT OF FIRE PREVENTION AND ELECTRICAL SAFETY MAY INSPECT ANY PROJECT AT ANY TIME DURING CONSTRUCTION OR UPON COMPLETION.

IF YOU WOULD LIKE A GUARANTEED INSPECTION, THE GUARANTEED INSPECTION FEE SCHEDULE IS ENCLOSED AND IS BASED UPON THE SERVICE AMPACITY. THE \$50.00 PERMIT FEE IS INCLUDED IN THIS INSPECTION FEE. THE INSPECTION MUST BE PAID FOR IN ADVANCE, AND THEN NOTIFY THE INSPECTOR IN YOUR COUNTY, WHO THEN HAS 5 BUSINESS DAYS TO COMPLETE THE INSPECTION. PLEASE NOTE: INSPECTIONS SHOULD BE SCHEDULED PRIOR TO COVERING UNDERGROUND INSTALLATIONS, CLOSING WALLS, OR POURING CONCRETE OVER ELECTRICAL COMPONENTS.

IF INSTALLING A GRID-TIE WIND TURBINE OR PHOTOVOLTAIC SYSTEM, YOU MUST PAY GUARANTEED INSPECTION FEE BASED ON THE SERVICE AMPACITY.

All other electrical installations-\$20.00 plus \$.50 per ampere rating of the electrical service.

Section 4. Re-inspections.

(a) **\$50.00 Plus \$.20 per ampere rating of the electrical service.**

(b) **For any requested electrical inspection conducted or electrical wiring permit issued by the Chief Electrical Inspector or his Deputy, a fee established by the Board by rule shall be paid by the person or contractor making the request. The electrical wiring permit fee shall be waived for anyone requesting and paying for an electrical inspection. The fees established by the Board shall not exceed the fees listed in, W.S. 35-9-120.**
