### GENERAL RULES AND REGULATIONS

1. The show is open to any person 21 years of age or under as of January 1, 2019.
2. Heifers are eligible to show if they are born between 9/2017-11/2018.
3. Heifers must be registered and shown in the exhibitor's name.
4. The market animal show is a preview show. No steer is eligible if it has been shown in a fat steer show prior to January 1, 2019. **All Steers Must Have Their Baby Teeth.**
5. Steer classes will be divided by breed and weight.
6. All cattle must be in place by 9:00 am April 7, 2019.
7. **SHOWMANSHIP - \$5.00 fee.** Showmanship will begin at 10:00 immediately followed by the heifer show and steer show.
8. This show is an MCCA sanctioned show & their rules do apply ([www.missouriclubcalfassoc.com](http://www.missouriclubcalfassoc.com))
9. No re-weighs on steers.
10. Calf must be shown by owner.
11. Entry forms are to be **postmarked no later than April 1, 2019** and accompanied by entry fee of \$50.00 per head. (Entry forms not accompanied with entry fee will be considered late.)
12. Late entries may be made at the cost of \$60.00 per head. Late entries will be accepted until 9:00 am April 7, 2019. **Late fees will be STRICTLY ENFORCED**
13. Registration certificates must be presented at check-in for all heifers. All animals must be free of infectious diseases. The Holden FFA Alumni reserves the right to eject any animal from the show and the grounds for the presence of warts, ringworms, etc. A certified veterinarian will be present on the day of the show.
14. Generators are encouraged.
15. **All exhibitors must provide and remove their own bedding.**
16. Name of Judge **WILL NOT** be disclosed.
17. **Alcohol is prohibited due to city ordinance.**
18. The Holden FFA Alumni and/or its members are not responsible for any accidents
