## FIRE DEPARTMENT:

Fire Department reported monthly runs so far have been 30 fire and 49 EMS for a total of 744 runs YTD. Mutual aid was provided to Amanda, Berne, Clearcreek, Bremen, Laurelville, Pickaway County, and Lancaster. A total of 9 run to SCI. Seen an increase in covid related calls. Multiple busy shifts for crews. Would like to bring to the board's attention a pay increase for the FY2021 for the EMS staffing. We also need to be talking about a fire truck replacement. The trustees all agreed and would discuss at the next meeting.

## **OLD BUSINESS**

- The county will keep Hocking Township informed as to the progress of the OPWC on Meister Road. Paperwork has been submitted.
- 2. Hocking Township will continue to monitor Stonewall Cemetery Road and Stepath Mound Lane for erosion.
- 3. Marathon Mini Mart is moving along at Delmont Road and Route 22. Slated to open in December.
- 4. Trustee Ellinger spoke with the county and the army corps of engineers about the muddy prairie run creek on Pleasant Valley. The Army Corp of Engineers is involved and are currently working on the issue.
- 5. Hocking Township will be submitting zoning resolution changes to Regional Planning next month. This has been postponed and rescheduled for mid-January.
- 6. An email was sent to Jon Kochis pertaining to the tornado siren at the Hamburg Park to replace parts on it.
- 7. Eric McCrady is checking on the guardrail issue at the property of 1925 Becks Knob Road.
- 8. Deputy Hummel and the Health Department will be checking on the property complaints on Hamburg Road. They will advise of the next steps.
- 9. James Mako has not heard of anything on the property at State Route 188 and Delmont Road.
