## BOARDING AGREEMENT

This is an Agreement between Hatteras Island Pet Resort and the pet Owner whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Hatteras Island Pet Resort.
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of the Hatteras Island Pet Resort. Owner further agrees to provide proof of a preventative flea/tick treatment program and to be financially responsible for any required treatment for fleas/ticks, if determined necessary by the Hatteras Island Pet Resort.
3. Owner further agrees that the pet shall not leave facility until all charges are paid to Hatteras Island Pet Resort by Owner.
4. By signing this Agreement and leaving pet with Hatteras Island Pet Resort, Owner certifies to the accuracy of all information given about said pet in this Pet Profile. Hatteras Island Pet Resort reserves the right to deny admittance to Owner's pet for any reason at any time.
5. Hatteras Island Pet Resort shall exercise reasonable care for the pet delivered by the Owner to Hatteras Island Pet Resort for boarding and or grooming. It is expressly agreed by Owner and Hatteras Island Pet Resort that Hatteras Island Pet Resort's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.<sup>00</sup> per animal boarded. The owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Hatteras Island Pet Resort, to include payment of costs for injury to staff or other animals or damage to facilities caused by pet. Hatteras Island Pet Resort reserves the right to separate dogs sharing a run for aggression, stress, illness or other safety concerns. A surcharge will apply.
6. Owner specifically represents that he or she is the sole Owner of the pet, free and clear of all liens and encumbrances.
7. Owner specifically represents to Hatteras Island Pet Resort that, to the Owner's knowledge, the pet has not been exposed to any contagious diseases within thirty day period prior to boarding. During the period of this agreement, Owner also agrees to notify Hatteras Island Pet Resort of any known exposure of pet to a communicable disease and hold pet out of attending Hatteras Island Pet Resort until pet is symptom-free for a minimum of 30 days or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Hatteras Island Pet Resort's policy.
8. All charges incurred by Owner shall be payable upon pickup of pet, or when billed by Hatteras Island Pet Resort at address listed on Agreement. Hatteras Island Pet Resort shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at the Hatteras Island Pet Resort. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this Agreement, Hatteras Island Pet Resort may exercise its lien rights upon ten days written notice given by Hatteras Island Pet Resort to Owner by certified mail to address shown on Agreement. Hatteras Island Pet Resort may dispose of pet for any and all unpaid charges, to animal shelter or private or public sale, in the sole discretion of the Hatteras Island Pet Resort, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, then Owner shall be liable to Hatteras Island Pet Resort for the difference. All monies realized by the Hatteras Island Pet Resort at such sale, over and above the charges due and costs of sale, shall be paid by Hatteras Island Pet Resort to Owner.
9. If pet becomes ill or if the state of the animal's health otherwise requires professional attention, Hatteras Island Pet Resort, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.
10. This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Hatteras Island Pet Resort.
