Cheri gave everyone a copy of the invoice from West Michigan Shredding in the amount of \$112.50, they came to the township and shredded 15 boxes in about 20 minutes.

Cheri gave everyone a copy of the cover letter to Allegan County Resource Recovery for the reimbursement for the 1st quarter 2023 recycling in the amount of \$4,100.71 for Casco. Brenda Katerberg, City of Holland, is recommending all clerks get in touch with their legislator and voice your concerns with Proposal 2. The State is proposing 9 days of early voting from 7:00am to 7:00pm. It will cost Casco Township \$2,952. This is with just one worker and Kathy's wages, and we may have to buy another tabulator which will cost approximately \$5,000.00.

The State needs to provide funding to local clerks that is not in the form of reimbursement.

On April 19, 2023, Kathy and I are hosting election Receiving Board training at 1:30. County clerk, Bob Genetsky will be presenting the training.

SHAWSA

Allan reported that they approved more led abatement work awarded to Compton's to comply with the Clean Water Act. There isn't any led in the system but there is galvanized pipes that need to be looked at.

Consumer Power is scheduling a power outage on April 22nd at the southeast corner of Casco along Baseline going towards 60th Street.

OLD BUSINESS:

• Miami Park Erosion

Debbie Weaver, 7271 Pacific Ave, explained a plan for the erosion litigation which includes the south part of Miami Park south of the stairs. There were several letters of support for the project and several opposed to the project.

Request from Linda Johnston to do some drainage in addition to the revetment project in front of her home at 649 Lakeshore Drive wants to install four drains across the front of her property to the revetment.

Paul made a motion to approve the installation of the four Wick drains. Supported by Dan. No further discussion. All Votes in Favor. Motion Carried.

Tire Day & Household Hazardous Waste

Tire Day on Saturday, June 3, 2023, Community Service people will be there to help load tires. Allegan County Resource Recovery is having a recycling event for hazardous waste at Harding's parking lot in Wayland on May 6th.

NEW BUSINESS.

2023/2024 Budget

Allan distributed the preliminary 2023/2024 budget but were waiting for the 4029 information from Equalization to complete the budget.

• Traffic Logix

Our movable traffic sign for renewal, we have an option to pay for several years at a lesser cost. Paul made a motion to lease the sign for 3 years at \$400.00 per year. Supported by Dan. No further discussion. All Votes in Favor. Motion Carried.

• Speed Limit Request

Allan received an email from Craig Atwood, D.K. Morgan requested the possibility of a speed limit reduction on 72nd St. south of N Shore Drive. Craig explained in his email that the State dictates how speed limits are set, and the process requires a township resolution requesting a traffic study. Allan asked us to look at it.

OTHER BUSINESS:

Allan gave the board a copy of the letter from attorneys, Straub, Seaman, & Allen, P.C. which the mediation occurred on April 10, 2023, and the plaintiff and co-defendant reached a resolution that will lead to dismissal of all claims against the Township and co-defendants. The Township did not need to concede any of its legal positions and no monetary contribution is part of the resolution. Allan attended the mediation per zoom and EMC Claim Representative, Stacy Harrish, on behalf of Casco Township.
