CHAPLAIN'S CORNER

DOG DAYS OF AUGUST –

Some of us experience lethargy and sense the energy draining from our bodies, like our lawns turning brown and the soil cracking from the drought usually brought on by the dog days in August. So, why do we call these days *dog days*? Is it because the dogs find this oppressive heat too much? The dog here is actually the Dog Star, which is also called Sirius. The star has long been associated with sultry weather in the northern hemisphere because it rises simultaneously with the sun during the hottest days of summer.

Yes, dogs do react to this oppressive heat with disorientation, increased heart rate, muscle tremors, or possibly seizures. These physical reactions overtake the dog, preventing it from being its usual fun-loving dog. The physical stress overwhelms the dog, and it reacts physically.

We humans are usually self-aware and can protect ourselves from this physical stress by cooling down and moving to a safer place. However, we sometimes let the other stresses of life overwhelm us – mentally or emotionally. Our reactions vary from person to

person, sometimes appropriately and sometimes not so appropriately. In the immediate reaction to an unpleasant circumstance, do we use the name of the Lord in an expletive manner? When overwhelmed by such emotional *dog days*, do we explode with the Lord's name inappropriately? The Bible specifically includes as one of the Ten Commandments, "You shall not take the name of the Lord in vain, for the Lord will not hold him guiltless who takes His name in vain". (Exodus 20:7).

When facing emotional *dog days*, we can do better than this. We can respect the Lord God and honor Him appropriately. Perhaps with practice, we could learn to use the Lord's name in a better way, as stated in Psalm 34:17, "When the righteous cry out to the Lord for help, the Lord hears and delivers them out of all their troubles".

Let us call out to the Lord in this way, so He can hear us and help deliver us from the stresses of life. ✍

“The Blues are Back!” The Blue Angels will be making an appearance at NAS Oceana celebrating their 76th anniversary and flying the demonstration in their brand-new F/A-18 Super Hornets. They will have the F/A-18 Super Hornet Tactical Demonstration, or “Tacdemo” which is world renowned as an awesome display of thrilling high-speed, high “G” maneuvers coupled with heart-stopping slow-speed performance. The Tacdemo highlights the incredible power and grace of the Super Hornet, affectionately known as the “Rhino”. Also featuring are the USAF F-16 Viper Demonstration Team, the USN Rhino Demonstration Team, and the U.S. Navy Leap Frog Parachute Team. You can also expect to see an Air Power Demonstration with Fleet Fly by and performances by local navy squadrons.

Council sends a bus of members and guests on the ‘Practice’ Friday of the 3-day event. Practice Day is the exact same show, but with smaller crowds. After successfully completing a seven-month deployment, **USS GRAVELLY** is officially back home! When **GRAVELLY's** Sailors arrived in Yorktown on June 20th, they eagerly awaited to see their family and loved ones. "I feel a sense of relief because I can finally see the finish line" CTRS N Mann said as she stood by as a linehandler.

GRAVELLY commenced her ammunition offload in Yorktown before she returned to Naval Station Norfolk. The Sailors worked hard day in and day out to ensure that **GRAVELLY's** ammunition offload was successfully completed so that she would be ready for her return to homeport. **GRAVELLY** remained in Yorktown for four days

before she was underway again for her official arrival in Norfolk.

On June 24th, the Sailors stood proudly squared away in their whites as they manned the rails in preparation to moor **GRAVELLY** in Naval Station Norfolk. As soon as the ship neared the pier, families and friends rushed to the edge of the pier to take pictures and cheered while the ship prepared to moor! Some of the people among the crowd held colorful "welcome home" signs showing support for their **GRAVELLY** Sailor. It was a touching sight to see Sailors go ashore and embrace their families.

The hard work did not stop for **GRAVELLY** when she arrived home. Damage Control-Industrial (DC-I) drills were conducted aboard often while Norfolk's Afloat Training Group observed the ship's readiness to respond to shipboard casualties. **GRAVELLY** met every drill with motivation and determination - **DO NOT GIVE UP THE SHIP!** **GRAVELLY** remained at Naval Station Norfolk for a week as she prepared for her berth shift to Marine Hydraulic International

(MHI). On July 5th, **GRAVELY** was moved to MHI to start her Incremental Selected Restricted Availability (ISRA).

USS GRAVELY RETURNS HOME TO NORFOLK 25 JUNE 2022

GRAVELY is the first unit to return from the Harry S. Truman Carrier Strike Group, which deployed in December. While deployed, U.S. 6th Fleet employed the ship to defend U.S., allied and partner interests, taking **GRAVELY** and her crew throughout a variety of European waters while providing a wealth of bilateral and multilateral training opportunities.

GRAVELY participated in exercises Neptune Strike 2022, Cold Response, Operation Songwright, Dynamic Manta, Neptune Shield 2022, and Hedgehog 22 with forces from Finland, France, Germany, Italy, Norway, Spain, Sweden, Turkey and the United Kingdom, highlighting **GRAVELY's** diverse mission set and capabilities while underscoring the importance of interoperability and operational readiness.

"Exercises with our Allies and partners allowed for a more cohesive alliance and fluid operations," said CDR Hunter Washburn, **GRAVELY's** commanding officer. "Operating with Allies

and partners is paramount to further developing our communication and operational capabilities to ensure mission readiness at a moment's notice."

GRAVELY's leadership hosted several distinguished visitors during port visits.

While in Klaipėda, Lithuania, **GRAVELY** hosted a tour and lunch reception with honored guests including the President of Lithuania Gitanas Nausėda, U.S. Ambassador to Lithuania Robert Gilchrist, U.S. Ambassador to Belarus Julie Fisher, and Minister of Defense for Lithuania Arvydas Anušauskas. Gravelly hosted the U.S. Ambassador to Poland Mark Brzezinski for a dinner reception in Gdynia, Poland.

The crew docked in Helsinki, Finland, along with dock landing ship **USS GUNSTON HALL (LSD 44)**, French frigate FS Latouche-Tréville (D646) and German frigate FGS Sachsen (F 219) over Memorial Day weekend, bolstering relations with a key NATO partner and Allied maritime forces.

"It is always a blessing to engage



with our Allied counterparts overseas in any capacity to showcase our enthusiasm and commitment towards our partnership", said CDR Brian Sánchez, **GRAVELY's** executive officer. "It was an honor to receive distinguished guests and visitors aboard our good ship **GRAVELY** during foreign port visits as a demonstration of our gratitude and appreciation".

GRAVELY also operated alongside the Kearsarge Amphibious Ready Group, comprised of Wasp-class amphibious assault ship **USS KEARSARGE (LHD 3)**, dock landing ship **USS GUNSTON HALL (LPD 44)**, and amphibious transport dock **USS ARLINGTON (LPD 24)** with the embarked 22nd Marine Expeditionary Unit (MEU).

The ship proved to be an integral part of the HSTCSG (Harry S. Truman Carrier Strike Group) during every phase of deployment.

"The professionalism and fortitude the **GRAVELY** has shown during this deployment has not gone unnoticed", said RADM Paul Spedero, Commander, Carrier Strike Group (CSG) 8.

"The crew gained an invaluable amount of knowledge of the region during their operations on this deployment, and their relationship with our Allies and partner nations show just how impactful our strike group ships can be".

The Harry S. Truman Carrier Strike Group (HSTCSG) includes flagship **USS HARRY S. TRUMAN (CVN 75)**; the nine squadrons of Carrier Air Wing (CVW) 1, commanded by CAPT Patrick Hourigan; the staff and guided-missile destroyers of **DESRON 28**, commanded by CAPT Todd Zenner, which include **GRAVELY**, **USS BAINBRIDGE (DDG 96)**, **USS COLE (DDG 67)**, **USS GONZALEZ (DDG 66)**, **USS JASON DUNHAM (DDG 109)** and the Ticonderoga-class guided-missile cruiser **USS SAN JACINTO (CG 56)**, commanded by CAPT Christopher Marvin.

Report from Tom Hassell, Liaison Vaughan F. Dize, Assistant Liaison

Greetings from **USCGC NORTHLAND!**

The ship and the crew have been very busy since our last update. On June 30th, **NORTHLAND** pulled into US Coast Guard Base Miami, FL to conduct a contraband offload with Drug Enforcement Administration (DEA), US Coast Guard District Seven, and U.S. District Attorney personnel. In total, **NORTHLAND** offloaded 2822 kg of cocaine, and 346 kg of marijuana, with an estimated street value of nearly \$109

million. Additionally, the ship transferred custody of nine foreign nationals, who were suspected of illegally trafficking narcotics across international borders, to the DEA. The interdictions of the suspected traffickers were the result of a cooperative effort from numerous US Coast Guard units in the Caribbean and Eastern Pacific Ocean. The contraband offload served as the final waypoint for a successful counterdrug patrol in support of Joint Interagency Task Force South (JIATF-S) and US Coast Guard District Eleven.

On July 3rd, after 76 days of deployment, the ship returned to her homeport of Portsmouth, VA, to a pier full of loved ones, friends, and excitement. Only a few days later, on July 6th, the ship and the crew said "Farewell and Following Seas!" to CDR Patricia Bennett, and welcomed aboard CDR Andrew Dannelly as the cutter's new Commanding Officer. The Change of Command Ceremony was conducted in accordance with the time-honored tradition of a sea-going ship's transfer of total responsibility and continuity of command, and served as a tremendous sendoff for CDR Bennett following a successful tour aboard **NORTHLAND**.

A week after the Change of Command Ceremony, having had a short time off for

R&R, the crew was back to work performing necessary maintenance and repairs on **NORTHLAND** to ensure that the ship is ready for her next deployment. As we near the halfway point of this in-port period, anyone on board can witness the hard work that the crew is putting in. Engineering Department is leading a top-end overhaul on one of the ship's main diesel engines; Deck Department is performing crucial corrosion prevention measures on the cutter's outer hull so that **NORTHLAND** not only looks good in the pictures, but is ready to withstand the hazards that heavy weather brings to underway vessels. Operations Department is busy conducting critical maintenance and repairs to law enforcement, navigation, and weaponry systems on board. Lastly, but certainly not least, **NORTHLAND**'s Support Department is busy procuring necessary equipment and tools to make certain that the ship is fully outfitted for her next deployment.

As we look ahead to the rest of this in-port and our next patrol, **NORTHLAND**'s crew is gearing up for what will be an exciting autumn deployment.
