- 1. Accounts are drawn up on accrual basis and on historical cost convention.
- 2. Accounting policies not specifically referred to are in conformity with the generally accepted accounting principles.

#### b. Notes On Accounts :-

- 1. HALE was incorporated as a Registered Society under the Societies Registration Act on 18th Decembe The Accounts have been drawn up for the period 18th December 2008 to 31st March 2010. This being the first Accounting period, the question of furnishing comparitive figures for the previous vear does not arise.
- 2. Registration Expenses of Rs 2280/- accounted in the Income & Expenditure Account represents Preliminary expenses.
