Rules & Regulations

1. “Nuts About Art” will be held on Saturday, July 4, 2020 at the John Dixon Park, 515 N. Galena Ave., Dixon, IL 61021 (regardless of the weather.) Event hours are: Saturday: 9:00 am– 4:00 pm.
2. All work exhibited must be original and handcrafted by the artist including painting, graphics, sculpture, jewelry, photography, drawing and artisan craft (clay, fiber, glass, metal, paper and wood). The limited use of manufactured items will be allowed, only if incidental to the final product and included in your photos.
3. There will be no judge of artwork or awards presented.
4. Booth fee per 10’ x 10’ booth (12’ x 12’ working area): **\$65.00 (post marked or emailed by April 30)**. \$75.00 beginning May 1 until the final deadline of June 1, 2020. **Multiple spaces are available.**
5. Submissions: Images of work (minimum of 3) may be submitted by email or regular mail. All images must be labeled clearly in whatever format chosen. Previous participants do NOT need to send images unless planned exhibit contents have changed. **Online:** Images must be in JPG format. The artist application may be scanned or the information emailed to nps@grics.net with images attached. Major credit cards and PayPal are accepted. **Mail:** Send application, payment and materials to The Next Picture Show (TNPS), 113 West First Street, Dixon, IL 61021.
6. All applicants will receive notification of acceptance by June 1, 2020. If you haven't received notification please contact us immediately at 815-285-4924 or by email at nps@grics.net.
7. There will be NO refunds after June 1. No refunds will be given due to the cancellation of the event by, an act of God, local authorities, or a weather related incident.
8. Artists must be present with their work for the entire event. All inventory, boxes, artwork, etc. must be contained within your booth area and cannot interfere with adjacent exhibits or walkways.
9. Artists are responsible for their own property and for furnishing their own tents, tent weights, tables, and chairs. Artists are responsible for insurance and protection of artwork and display.
10. TNPS reserves the right to use images provided by the artist or photographed at the exhibit for publicity purposes.
