QUICK FACTS:

Palestinian Children & the Israeli Occupation

And the King will answer them, `Truly, I say to you, as you did it to one of the least of these, you did it to me.'

Matthew 25:40

For five decades, millions of Palestinian children have grown up under Israel's brutal military occupation of the West Bank, East Jerusalem, and Gaza. These children live every day not knowing when their homes may be destroyed, or when they, their parents or siblings will be harassed, imprisoned, injured or killed by Israeli soldiers and settlers. Inevitably, many Palestinian children in the occupied territories face life with despair and hopelessness.


32 Palestinian children were killed by Israeli soldiers and civilians in 2016. Accountability for such crimes is virtually non-existent: **only** 1 incident resulted in an indictment.

In 2015, **30** children were killed and **over 1,700** were injured.

At least 540 Palestinian children were killed and over 3,000 were injured by Israel's 50-day assault on the Gaza Strip in the summer of 2014.

Half a million Gazans lost their homes in the 2014 Israeli assault that destroyed **20,000** homes and dozens of schools; due to Israel's blockade of Gaza, very little has been rebuilt. **50% of Gaza's population are children.**

The homes of **772** children were demolished in the West Bank and East Jerusalem, just in 2016. Since 1967, **tens of thousands** of homes have been destroyed due to the Israeli occupation.



Childhood essentials under threat:

physical security emotional stability adequate nutrition

education healthcare safe water

Every day, Palestinian children are exposed to and often confronted by Israeli soldiers in full combat gear, an act of violence in itself.



Living with TRAUMA

Over 50% of Palestinian children have experienced **high-magnitude trauma**: bombings, personal injuries, imprisonment, death of family members, and home demolitions.

82% of Palestinian children suffer moderate to acute levels of **Post-Traumatic Stress Disorder (PTSD)**

Living in POVERTY

25% or more of Palestinian families under occupation live in poverty; **78%** in East Jerusalem.

2.3 million Palestinians need humanitarian aid and1.6 million suffer from food insecurity.

10 Facts on Child Detention & Imprisonment



- Three out of four Palestinian children arrested by Israeli forces suffer physical violence. They are often blindfolded, handcuffed, and verbally and physically abused, from the moment of their arrest.
- 2. 136 young children from 7- to 11-years-old (under the age of criminal responsibility) were arrested in 2015.
- 3. Children are often arrested during terrifying night raids of their homes. Their parents don't know where they will be taken or if and when they will return.

- They are taken illegally from occupied Palestinian territory into Israel and often have **no family visits**; to enter Israel parents must have a permit that can take months to obtain.
- Most of these child prisoners have no access to lawyers and no adult protection when they are interrogated.
- **6.** Many children are **threatened** with reprisals against their families, **beaten**, and **tortured**, to force them to confess or agree to become Israeli informants.
- Many Palestinian child prisoners cannot read or write in Hebrew but are forced to sign confessions in Hebrew.
- 8. <u>Israeli</u> children living in the illegal West Bank settlements are tried in Israeli civil courts; only 6.5 % are convicted.

 Palestinian children in the West Bank are tried in Israeli military courts; over 90% are convicted.
- **9.** The most common charge against Palestinian children is throwing stones (defined in the same category as a bullet); Israel raised the maximum sentence to 20 years in 2015.
- 10. In 2016, Israeli military courts began sentencing children to years in prison for throwing stones. Israeli military law allows imprisonment for any child over 11 years old.

Military Courts: 500 to 700

Palestinian children go through the Israeli Military Court system every year. Israel is the only country in the world that systematically prosecutes children in military courts – only Palestinian children. These courts fail to uphold fundamental rights to a fair trial.
