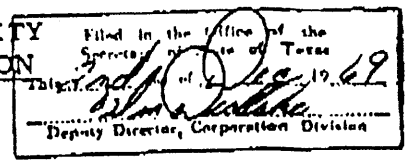

ARTICLES OF INCORPORATION

OF

PARKGLEN WEST COMMUNITY  
IMPROVEMENT ASSOCIATION



We, the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is PARKGLEN WEST COMMUNITY IMPROVEMENT ASSOCIATION.

ARTICLE II.

The corporation is a nonprofit corporation.

ARTICLE III.

The period of its duration is perpetual.

ARTICLE IV.

The purpose or purposes for which the said corporation is organized are civic and social, for the benefit and betterment of the residents and property owners of PARKGLEN WEST, a residential development in Harris County, Texas.

ARTICLE V.

The street address of the initial registered office of the corporation is 1740 Chamber of Commerce Building, 914 Main, Houston, Texas, and the name of its initial registered agent at such address is Larry D. Johnson.

ARTICLE VI.

The number of directors constituting the initial Board of Directors of the corporation is five (5), and the names and addresses of the persons who are to serve as the initial directors are:
