Jim updated everyone on the paving on Big Run. Half is being done now and the other half will be done next year. The dust and dirt on El Paso is being addressed, they are pouring concrete to keep the dust down. They will repair driveways and storm drains that have been crushed. Residents commended the road crew on taking care of the tree that fell during the storm this week in the mobile home park.

Chief Smith brought the request for the transfer of liquor license from 4212 Westview to 4103 W Broad St. The transfer was approved last year but they did not do the transfer before the paperwork expired.

The truck then goes several feet unmanned. Serval of the audience members echoed their concern with the same issue. Jessica also had to clean up glass and large construction nails in the roadway after the trash was picked up.

The board noted that the trash contract was not currently out for bid. Mr. Horn has approached the different haulers on his own time and spoke to them about pricing. Mr. Horn said his goal is good service and cheap. The board spoke about several options for possible trash service and haulers. At this time, no vote was taken and the board moved on without any further discussion on the pending trash contract.

Ralph Horn let the public know that the City of Columbus is not interested with working with the township for a J.E.D.D. There was never a contract that this would happen, there was a memorandum of understanding. Ralph spoke that possibly another group was interested but they preferred that it not be public at this time.

Janet Ward asked what will happen to the mall now that Sears is going out of business. The board does not know what the plans are for Sear or the mall at this time.

A reminder from Chief Smith that the block watch for Western Estates would be held July 9, 2017 from 3:00p.m. to 6:00p.m. no location was given.
