Where do I pay my property tax?

All property taxes are paid to the county treasurer's office where the property is located. You will find your county assessor or treasurer websites in the table on the right, simply click on the link for payment or other information.

What are the payment deadlines and late payment penalties?

The due date for the first half tax is October 1. The first half installment becomes delinquent after 5:00 p.m. on November 1 for Tax Bills over \$100. If Nov 1 falls on a Saturday, Sunday, or legal holiday, the time of the delinquency is 5:00 pm on the next business day.

After 5:00 p.m. on December 31, full year tax bills become delinquent. All tax bills under \$100 must be paid prior to that time. If December 31 falls on a Saturday, Sunday, or legal holiday, the time of the delinquency is 5:00 pm on the next business day after that date.

The second half tax is due March 1 of the following year and becomes delinquent after 5:00 p.m. on May 1. If May 1 falls on a Saturday, Sunday, or legal holiday, the time of the delinquency is 5:00 pm on the next business day.

You may pay both halves together until December 31. If you miss a deadline you may owe fees plus interest charges of 16% per year prorated monthly.

2016-2017 PROPERTY TAX CALENDAR

January 1, 2017

Delinquent 2015 taxes are assessed advertising fee.

January 3, 2017

2016 full year taxes equal to or under \$100 are delinquent after 5:00pm

January 31, 2017

Final date to purchase subtax and assignments. Assessor mails 2018 Notices of Value.

February 8, 2017

Internet Back Tax Lien Sale for 2015 taxes. Assignments available after all sale transactions are complete.

March 1, 2017

Second half 2016 taxes are due.

May 1, 2017

Second half 2016 taxes are delinquent after 5:00 pm.

June 1, 2017

CP holders may begin to subtax 2016 liens. Delinquent tax notices are sent to taxpayers for 2016 taxes.

Month of August

Board of Supervisors certifies 2017 tax roll.

Month of September

2017 Consolidated tax statements are sent to Mortgage Companies and to taxpayers without mortgages.

October 1, 2017

First half 2017 taxes are due.

November 1, 2017

First half 2017 taxes are delinquent after 5:00 pm for bills over \$100. (To ensure mailed payments are postmarked on the 1st, payments should be walked into the post office.)

December 1, 2017

Final delinquent tax notices are sent to taxpayers for 2016 taxes.

December 31, 2017

- Final day to pay 2017 current full year taxes without interest for taxes over \$100 (*).
- Full year tax bills equal to or under \$100 become delinquent after 5:00pm (*).

* If December 31 falls on a Saturday, Sunday or legal holiday, the taxes will accrue interest after 5:00pm on the next business day.
