

## **REDUCE YOUR FAMILY'S 2018-2019 TUITION RATE WITH THE "FACTS FINANCIAL AID APPLICATION TUITION CREDIT PROGRAM"**

OLPR understands the financial sacrifices that our families make to send your children to this school! One of our on-going goals is to make your tuition affordable. The primary way to offset the rising cost of tuition is through financial aid. So, beginning with the 2018-2019 school year we are requiring all families to complete a FACTS FINANCIAL AID APPLICATION. Every family that completes the FACTS application will receive a Tuition Credit and a Credit of the \$30 FACTS Application Fee.

### **School FACTS Financial Aid Application Tuition Credit Policy**

All families who register students in grades Pre-K 3 through 8 are required to submit a FACTS FINANCIAL AID APPLICATION for the 2018-2019 school year. In order for CURRENTLY enrolled families to be eligible, the FACTS application must be filed no later than February 28, 2018. For NEW families to be eligible, the FACTS Application must be filed on the same day they are registered in TADS.

All applications must be VERIFIED by FACTS. Only after each application has been verified will the family receive the FINANCIAL AID TUITION CREDIT and the \$30 FACTS Application Fee Credit.

The Tuition Credits are as follows:

- \$100 One Student Families
- \$150 Two Student Families
- \$200 Three or More Student Families

### **STEPS TO SUBMIT YOUR FACTS APPLICATION AND OBTAIN THE CREDITS**

1. GO to [www.BLOCS.org](http://www.BLOCS.org) and submit your FACTS FINANCIAL AID APPLICATION
2. Complete the below form and send it to the attention of Renee Roznietoski so we are aware that you have an active application in the FACTS system
3. Provide all required information and documents to FACTS making sure to follow all of the FACTS instructions
4. Make sure that you meet all of the FACTS Deadlines
5. After OLPR verifies that you FACTS Application meets all of the required criteria, your family's TADS account will be credited for the \$30 FACTS Application Fee and the appropriate Tuition Credit
