**RESOLUTION 2013-05**

**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS, FIRE DISTRICT #1, TOWNSHIP OF JACKSON, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE ADOPTION OF A TEMPORARY BUDGET FOR 2013.**

**WHEREAS**, New Jersey Statute N.J.S.A. 40A:14-78.17 permits the adoption of a temporary budget for all appropriations, a total of which shall not exceed 14% of the prior year's appropriations, excluding debt service and capital improvements in both instances; and

**WHEREAS**, the Jackson Township Board of Fire Commissioners, District #1, Ocean County, State of New Jersey, desire to adopt such a temporary budget for the year 2013 as there may be a need to make purchases from the beginning of the fiscal year until such time that the 2013 budget is finally adopted.

**NOW, THEREFORE, BE IT RESOLVED**, by the Jackson Township Board of Fire Commissioners Fire District #1, County of Ocean, State of New Jersey that it hereby authorizes the adoption of a temporary budget for the year 2013. The temporary budget for 2013 shall be in the amount of \$50,954.40.

This resolution shall take effect immediately.


