Summary: On August 9, 2021, officers responded to the 100 East block of Heather Rd. for a report of a dispute. Upon arrival, Officers learned that two neighbors were arguing about a parking spot when things escalated into a physical altercation involving various weapons. Juana I. Rodriguez and Kiaraenid Aletriz-Ayala were involved in mutual fight, during which Rodriguez struck Aletriz-Ayala with a small metal bat. Aletriz-Ayala then struck Rodriguez in the face with brass knuckles. No serious injuries were suffered by either party. Rodriguez and Aletriz-Ayala were arrested on scene and charged by investigating officers.

Rodriguez was charged with Aggravated Assault/Weapon, Possession of a Weapon for Unlawful Purpose, Unlawful Possession of a Weapon. Aletriz-Ayala was charged with Aggravated Assault/Weapon, Possession of a Weapon for Unlawful Purpose, Unlawful Possession of a Weapon, Prohibited Weapons/Devices. Rodriguez and Aletriz-Ayala were later released on a summons with a future court date in accordance with bail reform guidelines.

It should be noted that all person(s) arrested are innocent until proven guilty.
