

AMELIA VILLAGE, OHIO
Ordinance: O-2014-44

**AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, OHIO
AUTHORIZING THE PURCHASE OF A NEW VEHICLE FOR USE BY THE
PUBLIC SAFETY & SERVICE DIRECTOR AND DECLARING AN EMERGENCY.**

WHEREAS, Safety Services is in need of a new vehicle to efficiently and effectively perform its assigned duties;

NOW, THEREFORE, be it ordained, by the Council of Amelia Village, Clermont County, Ohio; that:

SECTION I This Council finds that it will be in the best interest of Amelia Village, Ohio to enter into a purchase agreement to acquire a new safety services vehicle to enable the Public Safety & Services Director to better perform her assigned duties.

SECTION II Council further finds that the required vehicle can be purchased through the State of Ohio without being submitted for public bid.

SECTION III Council authorizes and directs the Mayor and Fiscal Officer of the Village to enter into an Agreement to purchase a 2015 Ford Utility Policy Interceptor from Beechmont Ford, a dealer authorized to sell vehicles under the state procurement process, for the price of Twenty Six Thousand Three Hundred Six and 51/100 dollars (\$26,306.51).

SECTION VI Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements including Section 121.22 of the Revised Code.

SECTION VII That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village, and for the further reason that it is immediately necessary to approve this at the earliest possible time, in order for the Safety Service Director to effectively and efficiently perform the duties and obligations imposed by law. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

MR. CAMPBELL moved to suspend the rules requiring three readings on three separate dates.


