### FIRE DEPARTMENT:

Monthly runs so far have been 11 fire and 27 EMS. There were a total of 8 mutual aids provided to Amanda, Lancaster, and Berne, and Bremen. Trustee Claypool motioned to have the old EMS truck advertised for sealed bids by September 25, 2018. Trustee Ellinger seconded the motion. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe, Yes. Motion approved.

### OLD BUSINESS

1. The new ODOT signs are on schedule.
2. The property of Jon and Cathy Born is being worked on with Fairfield County Soil and Water.
3. Jheremy Bigham is scheduled to extend the culvert project on Hopewell Church Road to eliminate erosion. Project not to exceed \$1500.00. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.
4. Trustee Claypool working with Jheremy Bigham for quote on another project on Hopewell Church Road.
5. Trustee Wolfe working with Jheremy Bigham on the ditch project on Boice Road.

### NEW BUSINESS:

1. Terry Harvey is asking permission to set a stone with ashes in it beside the plots they currently have. There would be no excavating work done. Trustee Claypool motioned to approve the request. Trustee Ellinger seconded the motion. All were in favor with 3 ayes and no negative votes, motion passed.
2. There are fields on Westfall Road that have not been mowed in a couple years. Attempts to contact the owner have been made. A few complaints have been sent about this to the trustees.
3. The budget hearing is set for August 6, 2018 at 9:50am.

Trustee Claypool moved to pay the warrants for the month seconded by Trustee Ellinger. Roll call vote Ellinger – Yes, Claypool – Yes, Wolfe – Yes. Motion approved.

There being no further business to discuss Trustee Wolfe motioned to adjourn and Trustee Claypool seconded the motion.






