

# LVGA BYLAWS 2024-2025

The competition year is to begin on September 1<sup>st</sup> of each year. This association shall be known as the Las Vegas Gymkhana Association: hereinafter referred to as L.V.G.A. or LV Gymkhana and will be operated and conducted as a Non-Profit Corporation: L.V.G.A., is a nonprofit organized under and existing under Chapter 82 of the Nevada Revised Statutes.

**Purpose:** To promote good sportsmanship through competition of all ages. Equine activities of an athletic, social, educational, and recreational nature (NRS 82).

**Membership:** Any person may become a member upon payment of the proper dues. Membership is not limited to the State of Nevada, but membership is mandatory to qualify for year-end awards. Membership entitles the member to one vote (parents may vote for 13 years and younger children). Votes on major issues will be by private paper ballot. The Board of Directors will determine major issues.

**Membership Defined:** Membership is for one year beginning in September and ending in August of the following year. Active members aka Blue Members: Members who participate in the shows, meetings, and who actively assist with setting up, raking, tearing down, and judging during at least eight (8) shows and who are current with their dues. Non-Members aka Red Members: Those who do not actively assist with setting up, raking, tearing down, and judging during at least five (5) shows and who are not current with their dues.

**Blue membership** is when the contestant has filled out all necessary forms and paid all entry fees, membership fees, and sponsorship fees.

**Red membership** is when the contestant has signed all forms and has not paid the membership fee or sponsorship fee.

**NRS 82.031 “Member” defined.** Unless otherwise provided in the articles or by-laws, the word “member” means, without regard to what a person is called in the articles or by-laws, any person who on more than one occasion has the right to pursuant to the articles or by-laws to vote for the election of a director or directors. A person is not a member by virtue of any rights he or she has as a delegate or director or any rights he or she must designate a director or directors.

**Dues:** Annual Membership dues are \$40.00 per rider or \$80.00 per family of three (3) or more. “Family” constitutes, mom, dad, and their minor children. Membership dues are to be paid before any member may vote on rule changes for the following year, no later than the first show to be eligible for year-end awards and to maintain active membership status. New Members are required to pay their dues at the time of acceptance of membership. At any show in which the membership dues are not paid, the contestant will be required to pay the non-member entry fee of \$55.00. Contestant/Member will be responsible for bank charges assessed due to any returned checks (NSF) and a \$30.00 L.V.G.A. service fee per check. If a second check is returned for (NSF), L.V.G.A. will only accept certified funds or cash from the contestant.

**Sponsorship:** Sponsorship payment is due by the February show to be eligible for year-end awards. There will be no exceptions or extensions like previously allowed due to Covid hardships. Sponsorship

dues are a minimum of \$100.00 for all members. The sponsorship may only be used for that member or may be divided between those members family that ride.

**Meetings:** Either the President or Vice President shall call meeting at any time deemed necessary. No quorum is required for the transaction of business at a duly called membership meeting. Action shall be taken upon a majority vote of the active members present and any written proxies held by the Officers. The President will only vote in case of a tie. An annual meeting is to be held for the election of officers and any rule changes. The Board of Directors will have the decision.

**Election of Officers:** The Officers of L.V.G.A. shall be President, Vice President, Secretary, Treasurer, and two (2) Directors (Arena Directors), each serving a two-year term. Elections are held at the annual general membership meeting for the next gymkhana season. All officers are to be elected by a majority vote of the active members present and any written proxies held by the officers. Starting Officers will be a two-year term, then new officer elections will be held in 2024.

**Advisory Board:** An advisory board is made up of volunteers who offer their input, ideas, and expert advice to an organization's elected board of directors. Advisory board members are not legally bound but are important to the success of the organization through working with the board of directors. Without a strong board, nonprofit organizations may have limited success in meeting client and community expectations and needs.

What is an Advisory Board?

- Nonprofit organizations are structured through a board of directors whose members are responsible for running the organization through designated positions which usually consist of a president, vice president, secretary, and treasurer. The board sets policies for ensuring excellent management.
- An Advisory board, on the other hand, helps organizations get feedback, ideas, and opinions from the public. It does not have any legal or formal responsibilities but is convened to give advice and support to the board of directors.
- Having an effective advisory board is critical to organizational success. An advisory board plays an instrumental public relations role and provides the board with a fresh perspective on program issues. An advisory board works directly with the directors to brainstorm, discuss, debate, and decide major organizational decisions.
- Advisory Board Member Role: A Key to building a secure organization is having an independent advisory board of community leaders, parents, and other interested people. Advisory board members are volunteers and should reflect diversified representation from various cultures, socioeconomic groups, and urban and rural settings.
- Some advisory board members take responsibility for specific tasks while others only attend meetings and provide input and feedback. All members are expected to carry out a specific function independently. An advisory member's focus should be helping the board of directors with certain responsibilities, not replacing it. Both boards should work in a team effort with the organization's best interests in mind.
- Advisory board members usually attend between 2 to 12 board meetings each year to share information, discuss ideas, and make decisions. Once a structure is in place, the board can

distribute its governing functions and responsibilities equally among its members to maximize its effectiveness.

**Officers:** Positions elected are to include President, Vice President, Secretary, Treasurer (or combination Secretary/Treasurer), Arena Director, and Assistant Arena Director. Officers shall assume their positions for the upcoming season. The new officers will be announced at the awards banquet. The treasurer shall maintain a year-end balance of \$2,000.00 to be used for the first event of the following year and make available a financial report quarterly.

**President:** The President shall: 1) general: Ensures the effective action of the board is governing and supporting the organization and oversees board affairs. Acts as a representative of the board, rather than an individual supervisor. 2) Community: Speaks to the media and the community on behalf of the organization represents the organization within the community. 3) Meeting: Develops agendas for the meetings working with the vice president, presides at the board meeting. 4) Committees: Recommends to the board which committees are to be established, seeks volunteers for committees and coordinates individual board member assignments. Ensures each committee has a chairperson and stay in touch with chairs to be sure their work is carried out: identifies committee recommendations that should be presented to the full board. 5) Board Affairs: Ensures board matters are handled properly, including preparations of pre-meeting materials, committee functioning, and recruitment and orientation of new board members.

**Vice President:** The vice president shall: 1) General: Acts as the president/chair in his or her absence; assist the president/chair on the above or other specified duties. 2) Special Responsibilities: Frequently assigned to a special area of responsibility, such as membership, facility, media, annual banquet, assist with the judge's sheet to ensure there are not any family members judging for one another and to ensure it does not conflict with the running order as well.

**Secretary:** The secretary shall: 1) Keep accurate minutes of the annual meeting of general membership and the board. 2) Maintain current by-laws, policies, and forms adopted by the board or the general membership for reference by officers and members. 3) Handles all correspondence for the board. 4) Maintain inventory of the ribbons and order accordingly. 5) Accept membership applications/ entry forms. 6) Perform such other duties as may be assigned by the board.

**Treasurer:** The Treasurer shall: 1) Maintain a general fund and a special activities (gymkhana) fund. 2) receive funds and issue receipts for memberships, annual dues, assessments, and other fees. 3) Prepare and present an itemized statement of receipts and disbursements for general membership meetings. 4) Disburse funds at discretion of the board. 5) Co-sign L.V.G.A. checks with the president, make monthly deposits from shows. 6) Issue statements of dues assessments, and fees. 7) Prepare a budget for the board's approval. 8) Create running order and judges' sheet (this is a shared responsibility with the vice president). 9) Perform other such duties as assigned by the board.

**Arena Director:** The Arena Director shall: 1) The arena director is the keeper of the grounds, the individual who ensures all the functions of the show run smoothly, and the patterns are set up correctly. 2) It is their responsibility to ensure that the arena is prepped and ready for all competitions. 3) They shall make sure that the arena remains clean from trash, large rocks, and is dragged and watered accordingly.

**Arena Director Assistant:** The Assistant Arena Director shall assist the arena director in their duties. Should the arena director be absent, the assistant director will assume those responsibilities.

**Announcer:** The Announcer shall: 1) Announces program and substitutions or other changes to patrons. 2) Informs patrons of coming events, judges needed for events, contestant line up, times of contestant runs, sponsors, and various other announcements as needed. 3) If the announce is not an active board member they may not make any judgement calls or disqualifications on any run, they must wait for the board or judge's decision before announcing. 4) Music may be played during the event as long as everyone can hear all announcements.

**Authority:** The Board shall have: The administrative over all affairs and activities of L.V.G.A., the authority to implement assessments and dues increases with a majority of the board members present and a majority vote of the members present. Authority to expend funds as it deems necessary from the approved budget only. Recommend that any member engage or consult a veterinarian or farrier to provide a horse or other animal with treatment when, in the opinion of the board, such as treatment is necessary or advisable.

**Eligibility of Contestants:** Anyone may participate at an L.V.G.A. show. If a contestant is a non-member, \$20.00 will be assessed to the current entry fee. Non-members are not eligible for points or year-end awards. All contestants, members, or non-members must sign a liability release form before participating in any L.V.G.A. events.

**Eligibility of Horse:** Horses of any breed or combination of breed may be ridden. Stallions are not allowed on the grounds for any reason. No horse shall be ridden by more than 2 riders however the horse must only be ridden by 1 rider in any age division. The only exceptions are for horses injured during a show and for Pee Wee riders. Pee Wees can change their horse, depending on ability at any time during the year.

**Contestant Responsibility:** All contestants are required to read all the rules carefully. Failure to understand the rules is not an acceptable excuse.

**Point Horse:** Each rider must designate a point horse for the show year, Contestants must ride eight (8) out of ten (10) shows on the same horse to qualify for year-end awards, or with an authorized substitution, points will be added together. Switching horses during the show, without an authorized substitution will result in a disqualification for that event.

**Time Only Horse:** Any horse may be entered for a time only. All time only fee must be paid for before the rider may run. If a time only becomes desired due to a prior ride during the event, a time only may be requested, but you are not to approach the crowd's nest during said event to get approval. Please wait to approach board members when they won't be interrupted in their duties. (For example, wait till the drag is happening, change of age divisions, or change of event). Time only runs are based on availability and will be on a first come, first serve. During your time only please do not use this time to train, you can only go around a barrel or pole once and you must run the pattern as it is supposed to. If you continue to go around the same barrel or pole multiple times or make changes to the pattern you will be asked to leave the arena. There will not be time only runs at night events.

**Rider Substitution:** Rider substitution must be in the same age division as the rider they are substituting for and must be an L.V.G.A. member. A substitution form must be turned in prior to the show. Contestants may have two (2) substitutions per season.

In the event of a double show, any horse or rider substitution will only count as one (1) substitution within the same double show.

**Point Horse Substitution:** The substitution of a point horse may only occur with a letter from a licensed veterinarian specifically stating the horse can not run, or examination by at least one board member with the approval of two board members. A substitution form must be turned in prior to the show, unless the substitution is a result of an injury sustained during the show, if this happens the substitution form must be filled out and approved before the substitution horse enters the arena. If substitution paperwork is not filled out there will be no points awarded for the show. Only two (2) substitutions are permitted per season.

In the case of a prolonged injury, illness, or death of a contestant's point horse, another horse may be substituted to finish the season. A new point horse must be declared after both substitutions have been used. No points will be awarded until a new point horse has been declared. Pregnancy of a horse can only be used for two (2) substitutions. Pregnancy of a horse is not reason to grant a new point horse. Mental stress is not considered an illness or an injury.

If the original point horse becomes well, it may only be used as a substitute for the newly appointed point horse. A vet fitness certificate is required to ensure the health since it had previously been declared unsound.

In the event of a double show, any horse or rider substitution will only count as one (1) substitution within the same double show.

**Sale of Horse:** If a horse is sold, points previously earned by that horse will cease. Points do not continue with the new horse. The new horse will start a new point set. The point sets will not be combined.

**Equipment:** Any appropriate, neat, and humane western equipment may be used. Equipment must be of normal construction. Normal stirrup leather must be present and of usable length. Feet may not be tied into the stirrups. One light rubber band, per foot, is permissible. Every horse must have a bridal and reins. Riders may not be tied or Velcro into the saddle or onto the horse in any way, unless it is a medical necessity due to physical impairment of rider.

**Dress Code:** Clothing worn by contestants and anyone leading or assisting a Pee Wee on a lead line into the arena shall be western dress code. No English attire. Boots, pants, long sleeved shirts or sleeveless with finished seams are mandatory. Shirts with ¾ sleeves are not permitted. Shirts must snap or button down the front, collar button plus one (1) may be undone, long sleeves must be rolled down and buttoned. The L.V.G.A. t-shirt may be worn along with the western boots and pants, it must be without holes, sleeves must be rolled down and collars must be on the t-shirts. It is recommended that shirts be tucked in but its not required. You must have acquired the L.V.G.A. t-shirt by purchasing it through the club or by winning it. All western boots MUST have a heel. A coat or hoodie may be worn as long as the proper attire is worn underneath.

**Helmets:** It is MANDATORY for riders under 18 to wear a helmet when riding at LVGA competitions. (If you are under 18 and on the back of a horse you MUST have a helmet on). Helmets must be properly fastened protective headgear which meets or exceeds American Society for Testing and Materials/ Safety Equipment Institute standards for equestrian use and carries the SEI tag. It must be properly fitted with harness. All ages above 18, it is highly recommended for your safety.

**Timers:** An electric timer will be used at all shows and for all contestants. If there is a timer malfunction the rider will be given the opportunity to rerun right away or at the end of the age division. Two (2) stopwatches and a flagger will be used to time the event if the electric timers fail and cannot be repaired. The flagger will not move from their position until the end of the age division.

**Judges:** A minimum of two (2) judges, three (3) for some events will be positioned in the arena to properly judge each contestant for all events. The gate persons are also considered judges and will properly judge each contestant. No children are allowed in the arena unless riding. Judges must be the age of 13 or over. If Contestant/Member is not qualified to judge, a family member/guardian will then be assigned. There will be a two (2) minute call for judges when arena is ready. Failure to report for judging within two (2) minutes of arena being ready will result in the loss of 5 points for that show. If you are signed up to judge twice and fail to report again will result in the loss of another 5 points for that show. Electronic devices such as cell phones and MP3 players are prohibited in the arena while riding or judging (exception: officer radios). Failure to comply with the dress code will result in a disqualification.

**Age Divisions:** Your age division is determined by your age as of September 1<sup>st</sup>.

**Age Groups will be determined at the first show after sign ups.**

**Pee Wee Division:** Seven (7) years or younger or eight (8) years of age for first year riders (i.e., first year of riding and competing). The Pee Wee Division is a separate class from other divisions. Up to three (3) Pee Wee's may ride the same horse in this division. If riding lead line horses must be led from start to finish through the events and designated before the start of the event. If a Pee Wee is being led, the person leading/ and or assisting the Pee Wee must be at least 14 years of age, and in proper L.V.G.A. attire to enter the arena. If the person leading the Pee Wee is not 14 years of age, and not in proper L.V.G.A. attire, it will constitute as a no time for the Pee Wee. When leading a horse through the event, the horse must be the one to start and stop the timer. All Pee Wee riders must have reins and stirrups of useable length. All awards, monthly and year-end are paid from money raised from Pee Wee division riders. Ribbons and trophies will be donated if funds are not available. All other rules of the association will apply to this age division.

**Minors:** All children aged 17 or younger must always have a guardian at the show, in case of emergency.

**Points:** Points will go to the horse/rider combination (except for an authorized substitution). Points will be given to each contestant riding in the gymkhana in their respective age divisions. In case of a tie, contestant will receive the same number of points. Point sheets will be available at each show. Points are compiled as follows:

1<sup>st</sup> = 10 points + 1 point for each rider you beat

2<sup>nd</sup> = 9 points + 1 point for each rider you beat

3<sup>RD</sup> = 8 points + 1 point for each rider you beat

4<sup>th</sup> = 7 points + 1 point for each rider you beat

5<sup>th</sup> = 6 points + 1 point for each rider you beat

6<sup>th</sup> = 5 points + 1 point for each rider you beat

7<sup>th</sup> = 4 points + 1 point for each rider you beat

8<sup>th</sup> = 3 points + 1 point for each rider you beat

9<sup>th</sup> = 2 points + 1 point for each rider you beat

10<sup>th</sup> = 1 point + 1 point for each rider you beat

11<sup>th</sup> and below, will receive 1 point for each rider you beat.

**Show Awards:** Medals/Ribbons will be given for 1<sup>st</sup> through 10<sup>th</sup> place in each age division for each event. Prizes will be awarded at the next event unless it is the last show in which they will be given at the end of the show or at the end of year banquet. The Pee Wee division will receive medals/ribbons for each event and will be given prior to the event at registration.

Hi-Point and Reserve Hi-Point prizes will be given in each age division. Points will be calculated for hi-point and reserve hi-point as they are for awards to be given at the next shows registration. In the event of a tie, the rider's times will be added together for the entire show, the rider with the least amount of time will get the prize.

### **Year-End Qualifications:**

1. Contestants must ride eight (8) out of ten (10) shows.
2. Contestants must be an active member.
3. Contestants must acquire a minimum of \$100.00 in sponsorship donations.
4. Contestants can have one unpaid show and still qualify for year end awards. If you must miss another show, you can still qualify for year-end awards as long as you pay your entry fee for that missed show on or before the day of the show! You can't pay for missed show afterwards. Please make sure you send your money with someone or contact as to where to mail it.

**Year-End Ties:** In the event of a year-end tie, the two (2) places money will be added together and divided equally between the two (2) and the contestants will receive like awards. The next place will be eliminated. In the event of a tie for 10<sup>th</sup> place, contestants will receive like awards.

**Year-End Awards-** Points for year-end awards will be calculated on all ten (10) shows. At the end of the show year, an awards ceremony will be held. Awards will be given out to the top ten (10) places in each age division. Other awards may be given if deemed appropriate by show management. Riders that ride eight (8) out of ten (10) shows will receive a participation award; regardless of how many horses they have ridden. The Pee Wee riders will receive like awards regardless of how many year-end qualifiers are in that division.

All rules stated herein shall remain in effect the entire show year. Any rule changes proposed during the show year shall be presented to the officers and presented at the end of the show year. Rules may only be changed after the final show year. The Board of Directors will have final rulings on any changes. Rulebooks are available to all contestants at no cost.

**\*It is the member or parent/guardian's responsibility to verify spelling/accuracy of personal information (name, horse's name, sizing, color, etc.). This information may be used for personalized year end awards. Awards will not be replaced if the personal information matches that which member or parent/guardian verified via signature/initials.**

### **Ground Rules:**

1. Contestants are not allowed to ride in the main arena before the show begins.
2. Arena must be kept clear of all persons except the timer, judges, photographer, and the contestant when an event is in progress.
3. No horses will be allowed to be tied or standing next to the arena gate except for the next person to run.
4. No dogs allowed on the grounds. (Service dogs are allowed, emotional support are not)
5. The arena gates shall remain closed during a contestant's entire run.
6. The show management reserves the right to excuse any horse or person from the arena and/or grounds for any cause deemed sufficient. This includes but is not limited to abuse or inhumane treatment of horse, profane language, and/or sportsman like conduct.
7. Destruction of property such as grounds, building, or another's personal property will be cause for loss of points, suspension of one (1) show, or termination of membership for the remainder of the show year to be determined by L.V.G.A. officers.
8. All children aged 17 years or younger must have a guardian at the show, at all times, in case of an emergency.
9. No All-Terrain Vehicles (ATV) or Golf Carts are allowed on the grounds.
10. No running horses in warm up arena.
11. No entering the crow's nest during the events. This ensures that the judges in the crow's nest can give all riders equal attention and are not disrupted. (Please wait till the arena is being dragged, set up, or in between age divisions.)

**Arena Equipment:** Poles shall be made of PVC pipe and shall be six (6) to seven (7) feet in length and from one and one half (1 ½) to two (2) inches in diameter. Barrels shall be completely closed on both ends. All obstacles shall be twenty (20) feet from the arena fence.

**Starts:** Either a standing or running start may be made, but only after a contestant is completely in the arena gate. Contestants must enter the arena within thirty (30) seconds after their name has been called. Contestants must then start their run within forty-five (45) seconds after entering the arena and has sixty (60) seconds to complete the run, except for Pee Wees. Horses may be assisted into the arena, but the assistant may not cross the start/finish line except for the Pee Wee division and time only runs. There will be only one (1) rider allowed per horse. In case of breakage of tack outside the arena, the contestant must notify the gate person and sufficient time will be allowed for repairs.



**Re-runs:** In case of timer malfunction, contestant shall receive a re-run. If the timer is not repairable, the contestant along with the entire age division, shall receive a re-run with flagger and stopwatch. In the event a time was not recorded, due to timekeeper error, the contestant will receive a re-run. The contestant must take their re-run at the time or after the last rider in the age division.

Contestants will not receive a re-run for any of the following:

1. Any breakage of tack or gear once the timer has been started by the contestant/horse.
2. Any accident to the horse/rider once the timer has been started.
3. If the contestant fails to comply with all other arena rules, regardless of timer malfunction.

**Penalties:**

**A five (5) second penalty will be assessed to a contestant's run for the following:**

1. For each obstacle knocked down within the event.
2. Failure to show up to assigned judging spots.

**A \$5.00 fine will be assessed to each rider in each event for the following:**

1. Loss of hats or headgear while in the arena.
2. Personal items while in the arena (phone, hair tie, sunglasses, etc.).

**Disqualifications:** The following will result in a disqualification of the contestant:

1. Whipping, spurring, or striking the horse in front of the cinch at any time.
2. Failure to follow the prescribed pattern in any event.
3. Failure to comply with the dress code.
4. Failure to comply with the tack and equipment rules.
5. Use of foul language in the arena.
6. Harassing the judges and/or any L.V.G.A. member by a contestant and/or parent/guardian, family member, or trainer. This may result in a disqualification for the remaining year.
7. Failure to enter the arena within the thirty (30) second time limit.
8. Failure to begin the pattern within the forty-five (45) second time limit.
9. Unsafe running start beginning outside the arena gate.
10. Contestant or contestant's parent/guardian, family member, or trainer, who brings a dog.
11. Failure to ride in the order called by the announcer.

**Disqualifications for Events and/or Show and/or Membership**

**Any person whose actions deemed sufficient by the show management including but not limited to abuse or inhumane treatment of a horse, profane language and/or unsportsmanlike conduct could result in disqualification for the event, show, and/or membership for the year.**

**Entry Fees:**

There will be no refunds of money for point horses or time only horses for any reason.

Contestant/Member will be responsible for bank charges assessed due to any returned checks.

Pee Wee Division: \$35.00 per show.

Active Member (Blue): \$35.00 per show.

Non- Active Member (Red): \$55.00 per show.

Active Member (Blue) Time Only: \$3.00 per run per horse per event. Or two (2) runs for \$5.00.

Non-Active Member (Red) Time Only: \$5.00 per run, per horse, per event.

**ENTRY FEES MAY BE PAID BY CASH, CHECK, OR PAYPAL.**

Bank Fee: \$30.00 will be charged for a returned check.

**Running Position:** The Vice President of the Board will decide the running order prior to each show. Contestant must run in the order in which they are drawn. The Arena Director, and L.V.G.A. Officer, or the gate person must authorize valid reasons, such as tack problems, for changes to the order. All point rides will be completed before the start of all time only riders in each event. In the event of a substitution, one (1) rider may be moved to the bottom of the draw to allow sufficient time between rides. In the event both riders are already at the bottom of the draw, the first rider will be moved up five (5) riders from the bottom.

**Disbanding:** In the case of a committee disbanding, all monies and equipment obtained by the committee will be turned over to the L.V.G.A. Treasurer.

**Accounting:** At the membership meeting in August, the treasurer will submit an accounting of all funds received and expended in a form outlined and required by the Board, as audited by two members of the committee/board.

**Day Shows:** will start at 9:00 am and three (3) events will run including the standard two (2) events and one (1) rotating event. The rotating event will be different at each show. If weather becomes an issue (heat) we may start at 8:00 am.

**Night Shows:** will start at 6:00 pm and three (3) events will run including the standard two (2) events barrels and poles and one (1) rotating event. The rotating event will be different at each show. However, if the number of contestants is too great it is possible the event may start earlier.

**Events:**

**Standard Events:** The following events will be run at each L.V.G.A. show in which they appear: Pee Wee Division: Barrels and 3 P's. All Age Divisions: Barrels, Poles, and a rotating event. These may be run in any order as deemed necessary due to weather conditions.

**Rotating Event:** One of the rotating events will be run at each show, the events will be different for each show, and can be run in any order deemed necessary.

**The order in which the ages run will be rotating in order to be equal to all riders, except Pee Wee Division they will always be first.**

1<sup>st</sup> event order will be Pee Wee, under 12, 13-17, over 18.

2<sup>nd</sup> event order will be Pee Wee, 13-17, over 18, under 12.  
3<sup>rd</sup> event order will be Pee Wee, over 18, under 12, 13-17.
