1. Ordinance No. 3 of 2021

TITLE: AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF GREENWOOD, BY REZONING PROPERTY IN THE VACINITY OF 7300 BLOCK OF HWY 169 SOUTH, MORE PARTICULARTLY DESCRIBED IN EXHIBIT "A" TO THE ORDINANCE, FROM R-A, RESIDENCE/AGRICULTURE DISTRICT TO B-3, BUSINESS DISTRICT; AND OTHERWISE PROVIDING WITH RESPECT THERETO (Final passage)

2. Ordinance No. 5 of 2021

TITLE: AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF GREEN WOOD, PARISH OF CADDO, STATE OF LOUISIANA, FOR THE FISCAL YEAR BEGINNING JULY I, 2021 AND ENDING JUNE 30, 2022.

Town Clerk, Veronica Brown read the Ordinance by Title and went over each departments revenues and expenses. She also advised that this motion would be to introduce and set for Public Hearing on June 22nd. There was no discussion from the Board. A motion was made to approve by Alderman Doughty, seconded by Alderman Robinson. The motion was carried by a unanimous voice vote.

3. Ordinance No. 6 of 2021

TITLE: AN ORDINANCE TO ADOPT THE MILLAGE RATE FOR THE TAX YEAR 2021 FOR AD VALOREM TAX TO BE USED FOR GENERAL OPERATING PURPOSES.

Town Clerk, Veronica Brown read the Ordinance by Title and that the millage rate would remain the same at 9.95 mills and that this motion would be to introduce and set for Public Hearing on June 22^{nd} . There was no discussion from the Board. A motion was made to approve by Alderman Doughty, seconded by Alderman Larsen. The motion was carried by a unanimous voice vote.

4. Approval for the Regular Session Meeting which is scheduled for Monday, June 21st to be rescheduled to Tuesday, June 22nd, due to a LMA District "A" Meeting to be held on June 21st in Springhill, LA.

Town Clerk, Veronica Brown advised that the Town Governing Officials had a LMA District Meeting on the same day as the Regular session and asked to move it to the following Tuesday in order for the Aldermen to attend this very informative meeting. There was no discussion from the Board. A motion was made to approve by Alderman Doughty, seconded by Alderman Larsen. The motion was carried by a unanimous voice vote.

5. Ordinance No. 2 of 2021

AN ORDINANCE TO AUTHORIZE THE EXCHANGE OF SALE OF THE TOWN'S INTERESTS, LESS AND EXCEPT MINERAL INTERESTS, IN LOT F, BLOCK J, EXPRESSWAY SUBDIVISION, A SUBDIVISION OF CADDO PARISH RECORDED AS INSTRUMENT NUMBER 291839 IN BOOK 900, PAGE 567 OF THE RECORDS OF CADDO PARISH, LOUISIANA, FOR THE INTERESTS OF TALITHA MONROE AND RAQUITTA JAMISON IN LOT 89, GOLDEN MEADOWS SUBDIVISION, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, in October 2020 the Town of Greenwood mistakenly and through error issued a permit to Talitha Monroe and Raquitta Jamison for the placement of a mobile home on Lot 89, Golden Meadows Subdivision, when the zoning classification of the said property did not permit the placement of a mobile home thereon. By the time Town personnel discovered the error Talitha Monroe and Raquitta Jamison, in reliance on the issuance of the above described permit, purchased the property. When Town personnel discovered the error, after the purchase

of the property by Talitha Monroe and Raquitta Jamison, Town personnel rescinded the aforesaid permit; and

WHEREAS, the Town of Greenwood is the owner of Lot F, Block J, Expressway Subdivision, a subdivision of Caddo Parish recorded as Instrument Number 291839 in Book 900, Page 567 of the records of Caddo Parish, Louisiana, Expressway Acres Subdivision, having acquired title thereto when the property was purchased for the Town to construct a sewer treatment facility. Said property is properly zoned for the placement and maintenance of a mobile home thereon; and

WHEREAS, the above-described properties are approximately equal in value; and

WHEREAS, Talitha Monroe and Raquitta Jamison have proposed that they and the Town of Greenwood exchange their interests in the properties described above and permit them to locate their mobile home on Lot F, Block J, Expressway Subdivision, a subdivision of Caddo Parish recorded as Instrument Number 291839 in Book 900, Page 567 of the records of Caddo Parish, Louisiana; and

WHEREAS, Lot F, Block J, Expressway Subdivision, a subdivision of Caddo Parish recorded as Instrument Number 291839 in Book 900, Page 567 of the records of Caddo Parish, Louisiana, is surplus property for which the Town has no public use.

NOW THEREFORE BE IT ORDAINED by the Board of Aldermen of the Town of Greenwood, Louisiana, in due, regular and legal session convened, that it does authorize the Mayor of the Town of Greenwood necessary to execute all documents on behalf of the Town and approved as to legal form by the Town Attorney to exchange the interests of Talitha Monroe and Raquitta Jamison in Lot 89, Golden Meadows Subdivision, for the interests of the Town in Lot F, Block J, Expressway Subdivision, a subdivision of Caddo Parish recorded as Instrument Number 291839 in Book 900, Page 567 of the records of Caddo Parish, Louisiana

BE IT FURTHER ORDAINED that it any provision, item or application of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.

This ordinance shall be effective immediately upon approval.

First Reading: May 3, 2021 – Introduced, read by title, approved as read and set for Public Hearing on May 17, 2021 on motion by Alderman Edwardes and seconded by Alderman Robinson.

Second Reading: May 17, 2021 – Having been approved on the first reading on May 3, 2021, and after publication of notice and a public hearing, was read by title and approved as read on motion by Alderman Davis, seconded by Alderman Doughty and approved by the following roll call vote:
