- **I.** CALL TO ORDER: The meeting was called to order at 6:00 P.M. by Bob King.
- II. <u>DETERMINATION OF QUORUM</u>: The Annual Meeting originally scheduled for January 28, 2020 was rescheduled due to a lack of quorum. The quorum requirement for the rescheduled meeting is 25% (18 proxies and/or attendees). Fifteen (15) proxies were received by the Inspector of Election and four (4) owners attended, resulting in a quorum of the membership.
- III. INTRODUCTION OF THE BOARD OF DIRECTORS: No introductions were made.
- **IV.** MINUTES: There were no prior minutes to approve due to past lack of quorum.
- V. <u>FINANCIAL BUSINESS</u>: IRS Ruling 70-604: Whereas the members of Alder Point Owners Association wish to comply with IRS Revenue Ruling 70-604, in order to protect member assessments from taxation, do hereby adopt the following resolution:

"Resolved, that the members hereby vote to apply any unspent member assessments from the fiscal year ending December 31, 2020 to the members assessment of the subsequent fiscal year, as provided by IRS Revenue Ruling 70-604.

This resolution is adopted and made a part of the minutes of the Annual Meeting on February 11, 2020." A motion was made; second and carried. Motion passed unanimously.

- VII. OPEN FORUM: Discussion of Association rules.
- VIII. <u>ELECTION RESULTS:</u>

#### **Dear Members:**

Enclosed is your secret ballot to vote on the election of Directors. Please review these instructions *prior* to completing your *Secret Ballot*. Following these instructions better ensures that your *Secret Ballot* will be counted to determine the outcome of the election.

- A. Once you have reviewed the enclosed *Secret Ballot* and any supplemental materials regarding the election, please indicate your vote(s) on the *Secret Ballot* by putting an "X" or other distinguishing mark in the appropriate square(s).
- B. Three (3) Directors are being elected. Please do not vote for more than 3 candidates. **Please note:** If you vote for more than 3 candidates, none of your votes in the director election will be counted. You are not required to vote for 3 candidates; you may vote for fewer than 3 candidates if you wish.
- C. **<u>DO NOT</u>** write your name, address or lot number on the *Secret Ballot*. **<u>DO NOT</u>** sign your *Secret Ballot*.
- D. Once you have indicated your votes on your *Secret Ballot*, place the *Secret Ballot* into the plain smaller envelope (marked "Secret Ballot Envelope" or "Ballot Envelope"). Seal the smaller envelope. **DO NOT** sign or write anything on that envelope.
- E. Place that smaller envelope containing the completed *Secret Ballot* into the larger, Return Envelope that is pre-addressed to the Inspector of Election. Seal the Return Envelope.
- F. <u>Sign your name</u> and indicate your name and the address or lot number within the Alder Point Owners Association development that entitles you to vote, where indicated **in the upper left-hand corner on the front of the Return Envelope.** (Failure to sign the Return Envelope invalidates the enclosed *Secret Ballot*.)
- G. Add postage and deposit the Return Envelope in the mail. Please note, you will not be able to drop off ballots at the meeting. You will need to **MAIL** your ballot to **ARRIVE** no later than the close of polls, <u>Monday</u>, <u>January 25, 2021, at 5:00 PM</u> to:
